Bishop Egensteiner once again explained the procedure for speaking in favor of or opposition to a resolution or memorial by joining the appropriate breakout room. He then invited Pr. James Krauser to present the item for consideration.

RESOLUTION B:

A CONDEMNATION OF STATE-SANCTIONED VIOLENCE

Whereas, hundreds of Black lives are taken by American police every year;

Whereas, Black persons killed by police are more likely to be unarmed than white persons killed by police;

Whereas, Black male teens are twenty-one times more likely to be killed by police than white male teens:

Whereas, over 98% of police killings result in no charges for the officer(s) involved;

Whereas, in Lutheran theology, the state exists to preserve the world by establishing order and reigning in human sinfulness, and when the state fails in its preservative function, it is incumbent upon the church to remind the state of its God-given purpose;

Whereas, the United States has failed in its obligation to protect Black lives. Instead of protecting the rights of Black Americans, it has violated those rights, has criminalized Black people, and has established an intolerable system of police brutality and mass incarceration that targets Black lives;

Whereas, We cannot let police killings of Black people continue with impunity;

Whereas, We refuse to accept the idea that these police killings are inevitable; if the United States cannot put an end to the violence perpetuated by its own law enforcement

agencies, then it contradicts its claim to be a just state or an order of preservation; therefore, be it

RESOLVED, that the Metropolitan New York Synod of the Evangelical Lutheran Church in America does hereby proclaim:

- 1. Police killings of Black people is state-sanctioned violence and we condemn it;
- **2.** Jesus was a victim of state-sanctioned violence, and so identifies with all victims of state-sanctioned violence everywhere;
- **3.** To ignore violence against Black people in the U.S. is to ignore the cross of Jesus Christ;
- **4.** American Christians cannot be silent; a system of horror is operating on our watch, and we must stand up and declare it to be an unacceptable reality; it is incumbent upon the people of the United States to call on our government to account for its failure to live up to its God-given responsibility as an order of preservation;
- 5. We call upon all congregations to reflect on the implications of Jesus' identification with victims of state-sanctioned violence, and to lend their voices in support of those fighting for justice; as Psalm 103 says, "The Lord executes righteousness and justice for the oppressed," so too we should lift up our voices for the oppressed;
- **6.** We call upon President Joseph Biden and Vice President Kamala Harris, the U.S. House of Representatives, the U.S. Senate, and the Supreme Court of the United States to recognize the reality of systemic injustice in our criminal justice system, and to recognize that police brutality has become a national emergency;
- **7.** We call upon the United States to change our criminal justice system into a system of justice.

Bishop Egensteiner extended thanks to his staff, Synod Council officers and members, the churchwide representative, the Assembly planning committee, the Assembly chaplain, the Nominations and Elections committee, the Committee on Reference and Counsel, the Worship Committee, the Assembly Parliamentarian, and all the individuals who managed the technology to make the digital assembly possible.

He then closed the session with prayer at 11:52 am and invited the members to attend the Service of the Word for the Closing or the Assembly with the Rite of Installation of Synod Council members.
