Consideration of Appeal of Decision under S13.24 of the Metropolitan New York Synod Constitution

Bishop Egensteiner invited Secretary Schoepflin to speak of the constitutional provisions and continuing resolution related to the process of appeals, to report on the actions of the Synod Council under S13.24 and report to the assembly if any appeals were received.

After reviewing the reasons the Synod Council "may take charge and control of the property of [a] congregation" under S13.24 and the appeals process under Continuing Resolution SC 10:10/09, Secretary Schoepflin reported that on March 22, 2022 the Synod Council voted to apply S13.24 to Immanuel Lutheran Church, Manhattan, and that the congregation was informed of such action and of its right to appeal such action to the Synod Assembly. He further reported that Immanuel, through its legal representatives, had submitted a written notice of appeal.

Consultation Committee: Process for collecting Questions

Pr. Danielle Miller, Chair of Consultation Committee, explained how questions regarding the Committee's report on the appeal of Immanuel Lutheran Church could be submitted for consideration. She noted that a Question Submission Form needed to be completed and submitted to the committee by the close of the present plenary session.

Keynote Address: The Rev. Dr. Theresa Thames

Reference and Counsel

Bishop Egensteiner referred to the adopted agenda and standing rules in stating that 30 minutes have been allotted to this report of Reference and Counsel, that debate on any resolution would be limited to 15 minutes, and that any unfinished business of Reference and Counsel would be moved to Plenary Session V.

Pr. Martha Cruz and Pr. Rebecca Pollicino, co-chairs of Reference and Counsel were asked to present the resolutions that were submitteed.

Resolution 1: Nominations and Elections Bylaw

Whereas, the current bylaw S10.01.04 states that the terms of the members of the Synod Council (other than the officers) shall begin at the conclusion of the Synod Assembly (or Synod Council meeting) at which they are elected, which may limit flexibility in the timing of term commencement; and

Whereas, it is important to maintain a transparent and flexible nomination process, allowing Nominations from the Floor to accommodate the varying availability and interests of potential Synod Council members;

Now, therefore, be it resolved, that the bylaw \$10.01.04 be amended as follows:

The terms of the members of the Synod Council (other than the officers) shall begin at the date specified for each elected synod council position.

Resolution III: A Resolution to Encourage Using Retired Clergy to Support and Strengthen Congregations in the Metropolitan New York Synod of the ELCA

WHEREAS in recent years in many mainline Christian denominations in the United States there has been a growing awareness of the decline in both membership and financial support in many congregations as well as a decrease in the number of ordained clergy available, and

WHEREAS there is currently a substantial gap between the number of students enrolled in theological seminaries who are preparing for ordained ministry as well as an increase in the number of clergy who are retiring from active ministry or approaching retirement age, and

WHEREAS in the Metro New York Synod there are many congregations that do not have pastoral leadership because of the lack of candidates or because they lack sufficient financial resources to the support full or even part-time clergy to serve them, and

WHEREAS the ELCA, through Portico Benefits, provides excellent resources for assisting pastors considering their financial options for their retirement years that can enable them to continue serving after retiring without having to rely completely on local congregations for their personal financial support, and

WHEREAS there is a significant number of retired clergy who choose to remain available for serving in congregations and can continue serving in specific ways in local congregations, and

WHEREAS creating and implementing a comprehensive strategy on a synodical level for the use of the gifts of retired clergy able to serve the church after retirement could provide experienced pastoral leadership and benefit the ministries of local congregations, and

WHEREAS for several decades, in the U.S. and other countries, other Christian denominations have addressed similar concerns about providing pastoral leadership by creating numerous innovative models that train and use ordained and retired clergy and lay members to use their gifts in forming and serving as local shared ministry teams to support their Christian communities,

BE IT THEREFORE RESOLVED THAT THE METROPOLITAN NEW YORK SYNOD OF THE ELCA direct the Synod Council to form a synodical team, led by a qualified pastor, deacon, or lay person and including a synod staff person to:

- 1. conduct a study of innovative ways our synod can assist clergy making personal decisions about retirement as well as already retired clergy, to consider their options for continuing to serve the church after retirement, and
- 2. research and experiment with different models from around the world and other Christian

denominations for creating, training, and using shared ministry teams that make use of the gifts of all God's people, including lay members, rostered ministers, and retired clergy, on a salaried and a voluntary basis, to serve and support local congregations and conferences, and

3. oversee, foster, and assist in creating local and conference strategies for shared ministry, by providing training for clergy and local congregational leaders that will enable them to create and serve in shared ministry teams in their own local settings.

After breakfast forums Bishop Egensteiner opened the fourth plenary session at 10:00 am by inviting Pr. Koran to begin the session with prayer.

ELCA Churchwide Report

Ms. Jodi Slattery, Executive for Governance in the ELCA, gave the church report following a churchwide video. She spoke of the many ministries of the ELCA and expressed gratitude to the MNYS for its partnership and support.

Consultation Committee Report II

Bishop Egensteiner asked Pr. Danielle Miller to respond to questions that were submitted by the voting members of the Assembly.

The Pastor and members of Immanuel Lutheran Church were given an opportunity to respond to the report.

Bishop Egensteiner then opened the floor for voting members to speak for or against the motion to sustain the action of the Synod Council in imposing S13.24 on the congregation. He reminded the members that each speaker would be limited to 3 minutes.

At the close of this period Bishop Egensteiner led the assembly in a vote on the question, reminding the voting members that the question before them was; "Shall the action of the Synod Council in exercising Section 13.24 of the Synod Constitution in relation to Immanuel Lutheran Church, Manhattan, be sustained?" He noted that a "yes" vote would sustain the action of the Synod Council and a "no" vote would overturn the action of the Synod Council.

269 votes were cast: 200 in favor of sustaining the action of the Synod Council, 69 in favor of overturning it.

The motion passed.
