8. New Business

A. Christ Lutheran Church, Little Neck

WHEREAS, the congregation of Christ Evangelical acknowledged that it was no longer possible for it to function as such and voted to disband, pursuant to section 13.24 of the Constitution of the Synod. In addition, the Synod Council is of the opinion that the membership of the congregation of Christ Evangelical has become so scattered and so diminished in numbers as to make it impractical for that congregation to fulfill the purposes for which it was organized and that it is necessary for the Synod to protect the congregation's property from waste and deterioration, and therefore it is in best interests of the Synod to take charge and control of the property of Christ Evangelical and to hold, manage and convey the same on behalf of the Synod; and

WHEREAS, title to the real and personal property of Christ Evangelical shall pass to the Synod (and/or the Property shall pass or be transferred to the Synod LLC to insulate the Synod from liability and for other reasons); and

WHEREAS, in furtherance of that purpose, the Synod may (but is not obligated to) form a limited liability company organized under the laws of the State of New York, in which the Synod shall be the sole member and manager ("Synod LLC") and transfer the Property to the Synod LLC. The sole purpose of Synod LLC is and shall continue to be to hold, manage, and convey title to the real property formerly of Evangelical Lutheran for, on behalf of, and at the direction and convenience of the Synod. No other assets shall be placed in the Synod LLC and the Synod LLC shall have no liabilities.

NOW THEREFORE, be it

RESOLVED, that for the reasons set forth above, all of which are included and incorporated herein and made a part hereof as if fully set forth, the Synod, pursuant to Section 13.24 of its constitution and New York Religious Corporations Law section 17-c(2), does hereby

take charge and control of the real and personal property (including the Property) of Christ Evangelical to hold, manage, and convey it on behalf of the Synod; and it is further

RESOLVED, that the dissolution of the Synod is not contemplated following the transfer of the real and personal property of Christ Evangelical to the Synod and upon the formation and transfer the Property (if applicable) to the Synod LLC.
