3. New Business

A. Fordham, Bronx

Branden Dupree (DEM) and Mo. Gladys Diaz presented report to the Synod Council regarding the deteriorating conditions at Fordham. Information was provided by congregation officers, appointed pastors that have served the congregation, and synod staff members that have met with leadership.

ACTION SC23:6/01

RESOLVED, that the Synod Council, pursuant to section 13.24 of the Constitution of the Synod, does hereby impose synodical administration / preservation over Fordham to take charge and control of the property of Fordham, and to hold, manage, and convey that property on behalf of the Synod; and it is further

RESOLVED, that the following are hereby appointed as trustees, with full power to hold, manage and convey the property of Fordham on behalf of the Synod in all regards relating directly or indirectly to the taking charge and control of the property of Fordham and in holding, managing and conveying that property of Fordham on behalf of the Synod, to wit: The Rev. Gladys Diaz, Branden Dupree, Christopher Vergara; and it is further

RESOLVED, that the signatures of any two of the Trustees acting to take charge and control of the property of Fordham and to hold, manage and convey the property of Fordham on behalf of the Synod shall be binding upon and considered as the act of all of the Trustees. No person or party acting in reliance on the signature of one such trustee as binding upon all Trustees shall be charged with notice of any revocation or change of such authority unless he, she or it shall have received actual written notice thereof. No person or party shall be required to look behind the signature of such Trustee. ADOPTED

B. Unidad y Fe

a. Expenditures

In January 2021 the SC approved the proposed costs (architectural / construction) for the build out of Unidad y Fe (formerly Todos Los Santos) in Woodhaven. At that time, it was not known that the kitchen's industrial oven / stove was not working correctly or within code. A functioning kitchen is a critical element in building community within this newly formed Synodically Authorized Worshiping Community (SAWC) and a tool for outreach to the surrounding neighborhood.

b. Extended Lease

The original lease for the Unidad y Fe property was signed for 5 years (to end in Jan 2026). An extended lease for an additional 5 years with 4% annual rent escalations, as well as an option to renew for an additional 5 years after the extension with 5% annual rent escalation.

ACTION SC23:6/02

RESOLVED, that the Metropolitan New York Synod Council approve the expenditure of \$100,000 for the Unidad y Fe ministry site and the five-year extended lease with 4% annual rent escalations through January 2031 with the option for an additional five-year extension with 5% annual rent escalations. ADOPTED

C. Christ Center, Harlem

The Bishop's staff is currently exploring options to present to the Vision Team / EC / SC regarding the Christ Center property located at 70-74 W 126th Street, Harlem. The congregation wasn't in the building for two years during the shutdown and found the building to be unsafe after a handful returned in late 2022. Concerned about safety and liability, we closed the buildings. The congregation is mostly commuters - online worship has worked and continues to work for them. The building is vacant.

We'd like the SC to give authorization to list the property so we may get a sense of the market value and determine if there is any interest in the property.
