Without additions or corrections the November minutes were approved.

With regard to Item D on page 5 of the November minutes, the secretary reported that further investigation indicated the original resolution SC01:7/6 read that the initial funding was for two years.

V. REPORT OF THE BISHOP

- Α The bishop reported on a number of personal concerns for rostered persons.
- В Congregation issues: Redeemer, Hicksville will be closing on February 22, 2004
- C. Synod Issues
 - 1 Consultations
 - St. Paul's Valley Stream a)

A letter of concern from members of the congregation raised some issues that the bishop felt deserved follow-up. The bishop is initiating a consultation process to further explore the situation. He briefly explained what such a process entails.

The report of the Consultation Panel becomes binding, once it is approved by synod council.

b) Zion St. Mark's German

It was felt that the consultation discussed last month for this congregation should be delayed until the pending excommunication appeal case is resolved.

c) St. John's Bronx

Many requests for a consultation have come from members of the congregation; it will begin in the near future.

2. Advisory Panel:

An Advisory Panel, as opposed to a Consultation Panel, will offer assistance to Atonement, Staten Island in assessing their future. This is not a conflicted situation but one of very low membership. Atonement is in a key strategic location on Staten Island.

- 3. Pastor Kris Baudler. Notes from the meeting with Pastor Baudler have been sent to the ELCA attorney, Mr. Phil Harris, who is preparing next steps.
- 4. A meeting with pastors in specialized calls will be held on March 22. Pastor George Handzo is helping with the convening of this meeting

5. Survey of Missions (Attachment A)

Bishop Bouman discussed the conversation at the Bishop's Academy with regard to the broad concerns throughout the church on clergy supply and mission. He has prepared a summary of 60 ministries which are supported by the synod, especially those which are multicultural in their scope and staffing. He reviewed many of the details of the summary.

D. Public Issues

Lutheran Ministries in Higher Education (LMHE). Issues at LMHE and lack of resources have made necessary a consultation to look at campus ministry. The consultation will include the LMHE board, Pastor Gaylon Barker representing the MNYS, and a representative from the Atlantic District.

Pastor Krauser suggested that in the future a committee of the synod council be appointed to review the Synod Assembly minutes so that the whole council will not have to study it. Mr. Litke will put this on the agenda for the retreat of the new synod council in June.

Mr. Litke described the status of the issues at Holy Trinity, namely that the scope of repairs remain beyond our ability to pay – approximately \$1,000,000. In order for the synod to pay for these repairs, we would have to mortgage the building and make payments of approximately \$80,000 per year for the next 30 years. At this time we cannot make a recommendation to go forward, and the inability to do so probably means the school would not be able to open next year. Mr. Kamy Moghbeli questioned the reliability of the architect's \$1,000,000 estimate to make the necessary repairs. Pastor Cherlyne Beck assured him that this number was investigated carefully.

D. Synod Council membership

Mr. Litke reviewed the requirements of attendance and noted that as of the conclusion of this meeting we would have four vacancies, one due to resignation (the Rev. Amandus Derr), one having left the synod (the Rev. Stephen Marsh), and two for non-attendance (Ms. Joanne Means and Mr. Matt Gieser). Since there is insufficient time to fill these vacant seats before the next election, Mr. Litke noted that future quorum counts would be based on the number of seats held (17).

F. NEW BUSINESS

A. Synod Assembly

1. Voting member apportionment for 2004 Assembly:

ACTION (SC04:1/9): RESOLVED that the apportionment of voting members for the 2003 Synod Assembly be as follows:

"authorized worshipping communities" 1 lay voting member
Up to 699 baptized members 2 lay voting
members
700-999 baptized members 3 lay voting members
1,000 and more baptized members 4 lay voting members

ADOPTED

There was discussion as to the definition of an "authorized worshipping community". Mr. Litke will provide this definition to council and we will include this definition in the mailing to the synod announcing the assembly.

Pastor Bill Hurst suggested that in the future we use average attendance at worship rather than baptized membership as a basis for this apportionment.

2. Registration fees

In the past the registration fee has not covered meals, which have been optional. Hotel contracts require meal guarantees and meals not purchased still have to be paid for by the synod. This has meant a cost to the synod of \$40,000 to \$50,000 per year. The assembly planning committee determined that the only way to prevent wasted costs would be to include the meal package with the registration fee. Cost of rooms would be in addition. The following resolution was moved and seconded:

MOVED: That the registration fee covering both registration and meals, for the 2004 synod assembly be set at \$300 with a discount of \$25 for early registrations (before March 1) and a late fee of \$25 for those paying at the door.

After lengthy discussion it was moved and seconded to amend this resolution. The following action was adopted:

ACTION (SC04:1/10) RESOLVED than the registration fee for the 2004 Synod Assembly be set at \$175, which includes the meal for Thursday evening, and that separate meal tickets be offered for purchase.

ADOPTED

Thursday evening's meal was included because there will be the recognition of this year's Distinguished Disciples at this time. The synod's communication to the congregations will include strong encouragement to buy into the meal plan.

3. Distinguished Disciple

There will be three Distinguished Disciples recognized at this year's assembly. Names will be presented at the February synod council meeting.

4. Mission Moments will focus on worshipping communities; videos from congregations are encouraged

B. Offices to be elected and nominations received from conferences – The Rev. Jim Krauser

Pastor Krauser reported that the synod council nominations process has worked well. One conference has made no nominations; one conference has nominated only one candidate. Current lay members of the council are invited to consider running for at-large seats.

C. Housing Allowances

Section 107 of the Internal Revenue Code permits a minister of the gospel to exclude from gross income (in computing federal income taxes) a church-designated allowance paid as part of compensation to the extent used for actual expenses in owning or renting a home.

Bishop's Report to Metropolitan New York Synod Council Our Shared Missions Bishop Stephen P. Bouman Commemoration of Martin Luther King September 19, 2004

The Conversion of the Church

In Acts Chapter 11 Peter reports to the church about the conversion of Cornelius. But what he is really reporting is his own conversion and the conversion of the Church to this mission among the Gentiles. "If then God gave them (Cornelius' household) the same gift that he gave us when we believed in the Lord Jesus Christ, who was I that I could hinder God? Then God has given even to the Gentiles the repentance that leads to life." (Acts 11:17,18) Peter recognized, and reported to his own synod council in Jerusalem that God was already at work in other cultures before he showed up.

The conversion of the Church to outreach in our neighborhoods and this new wave of immigration among us is the point of the Commission for Evangelical Outreach which our synod assembly enabled last Spring. That conversion is ongoing in our synod. It is bringing us new life and vitality, and is reshaping our life and mission. In the days after Christmas I had several sessions with our mission leaders to get an accurate picture of our shared missions in this synod and our outreach to ethnic specific groups and people in poverty. We analyzed every single new mission start, including who was being served, how many were involved, mission leadership and partners, and the resources needed to accomplish the ministries. Tony Aguilar has been leader and developer of our Black Mission Strategy; David Anglada is leader and developer of our Latino Mission Strategy and our Division for Outreach ministries; Lily Wu coordinates our Asian Mission Strategy; and Gary Mills coordinates our international ministries. They, with Bob Wollenburg our director for resource development, participated in these planning sessions. Here is a report on our shared missions, a glimpse into a synod being converted in its encounter with Cornelius in our own time.

A Mission Snapshot

Here is a summary of our ministries, with detailed commentary to follow in the next sections of this report. There are more than sixty ministries, and most of them involve people in poverty and immigrants\refugees. We are a Great Commission Synod "in the breach."

Black Strategy: Although the ELCA uses a number of 30% Black to identify Black ministries, we use 50% in our synod.

- *There are 29 congregations with over 50% Black membership.
- *13 are being served by Black pastors (including one from the Reformed Church), 11 are being served by White pastors, 2 are being served by Black synodically authorized lay leaders. 6 congregations are vacant. Two black pastors are serving White congregations.

Four Black pastors are Diakonia graduates, and several graduates are in the TEEM candidacy program. We are growing our own future leaders.

- *These churches have a membership of 7398 and an average attendance of 2841. (Our synod has many other Black members who are not in these 29 congregations)
- *Mission support is 9% of the total income. The congregations as 13% of our total congregations.
- *The Black Strategy is coordinated and planned by the Black pastors group (which includes White pastors of Black churches and lay leadership) convened by Tony Aguilar. Key to the strategy is to invest in existing ministries rather than start new ministries. Several of these ministries are now resources for the entire synod. St. Paul, Parkchester; Epiphany, Brooklyn; Holy Redeemer, Brooklyn; New Hope, Queens, and Our Savior, Queens are examples of ministries sharing leadership, new mission initiatives and strong internal growth with the synod. The Black Strategy received significant funding from Thrivent for the training of lay mission leadership through an annual leadership institute. *Five of our Black congregations receive partnership funding (national division for outreach or synod) and three were Jubilee congregations receiving 750k in debt relief. *Black Lutherans are about 12% of our synod membership. The ELCA is about 1.5%.

Latino Strategy: There are 15 Latino ministries in our synod, from Kingston in the north through the five boroughs to Amagansett in the East end of Long Island. This strategy is directed by David Anglada, who meets regularly with those serving these ministries. *7 are new ministries started in established congregations; 4 are established Latino

- *7 are new ministries started in established congregations; 4 are established Latino ministries within established congregations; 3 are Latino congregations; 1 is a redevelopment of a dormant ministry (Sion in East Harlem).
- *these ministries are being served by 7 deacons (graduates of the Spanish Diakonia program), 3 White pastors, 2 Latino ordained pastors from other traditions (Reformed and Pentecostal, both in candidacy process), 2 Latino candidates approved for ordination (one a Diakonia graduate) and 2 ordained Lutheran pastors (a Diakonia graduate). Again, we are growing our own leaders.
- *These ministries have an average of 650 at worship. There are about 2000 Latino members of the MNYS.
- *There are currently 8 TEEM candidates, 16 graduates of Diakonia, and 12 in the candidacy process. There are 13 current students in the Brooklyn track of Diakonia, and 11 students in the Hempstead track.
- *Some of these ministries are growing rapidly. Last week the ministry at St. Luke's, Woodhaven had 93 at worship (they began about three months ago); the ministry at St. Peter's, Manhattan often has more than 150 at worship.
- *Most of these ministries serve a predominantly undocumented population. 80% of those at Cristo, Freeport are undocumented, and almost 100% in Hempstead.
- *We have a goal of starting two new ministries per year.
- *It costs about \$25,000 a year to support a deacon serving as a mission developer.
- *Possible new mission sites for Latino outreach in contemplation or development include: St. Lukes, Times Square; Staten Island; Tarrytown\Ossining; Haverstraw\Spring Valley; Beacon\Newburgh

Asian Strategy: There are 9 Asian ministries in our synod. Eight are Word and Sacrament ministries and 1 is an outreach to Fujianese immigrants in Chinatown through LSS and LDRNY, with Word and Sacrament in the planning stages. Lily Wu relates to these ministries and Abraham Lu has been a long time leader.

- *These ministries worship about 635 people weekly. There are about 1800 Asian people in the congregations of our synod.
- *A key element in drawing these ministries together was a synod wide youth retreat held recently at Koinonia. It was very well attended.
- *Our most recent Asian ministries are Kalam Taiwanese (received into membership at our last Synod assembly, and Ashirwad South Asian ministry.
- *During this week Gary Mills is meeting in Beijing with leaders of the Batak national church in Sumatra to identify our next pastor and work through other agreements.
- *We have submitted a ministry profile to the Division for Outreach for funding a new English ministry for 2nd generation Chinese at Grace.

Companion Synod, Immigrant and Rural Ministries: Pastor Gary Mills works with our international ministries and our Companion Synod relationship. Tony Aguilar works with the Committee for Ministry among Guyanese.

- *Our synod supports two ministries in the more rural part of our territory at Ellenville and Jeffersonville. These are small, but vibrant ministries which could not exist without our partnership.
- *We have developed "church to church" agreements with the churches in Finland, The EKD in Germany, Sweden, and Norway. Our agreement with EKD includes synodical involvement with St. Paul's in Manhattan, and the sending of interns and pastors to serve in our synod from Germany. Finland has sent much support and resources for our synod's outreach to immigrant and expatriot Finns.
- *Pastor Gary Mills has made key visits in support of our Asian ministries.
- *Outreach among Liberian refugees on Staten Island has local sponsorship.
- *I had the opportunity to meet Pastor El Yatim and Grace's family while visiting in the Holy Land with Bishop Hansen. Salaam continues to be a crucial ministry for us.
- *Our Savior, Jamaica incubated our Swahili ministry, and now hosts worship for the Tamil community.
- *New immigration ministries being considered include Russian (Washington Heights or Brooklyn), French\Creole, and German (Westchester County).

New Ministries: Twenty three new ministry starts (or re-starts) have been initiated since I was elected bishop in 1996. This impetus for mission planting builds on the extensive work done in previous years. They include nine Latino ministries, and six Asian ministries. Some are the merging of existing ministries: Cristo\Christ in Freeport; Grace Chinese\Bethany Elmhurst\second generation outreach. Some are local parish initiatives: Tamil at Our Savior. Most were initiated by synod and local partnerships. Two Latino ministries were initiated which were not able to be sustained (Poughkeepsie, Mt. Kisco). Four congregations have closed.

Congregations at Risk, Congregations Renewed: Most of these new ministries have started in existing congregations. Of the twenty congregations who are partners or hosts of these ministries, fifteen are congregations at risk. Among them:

- *Latino mission starts in Woodhaven, New Rochelle, Jackson Heights, Flushing.
- *One is a new missions start out of a closed congregation (Hope, Scarsdale).
- *Several have the potential to develop in a similar way to Salem\Salaam in Bay Ridge, where a vulnerable congregation opens toward a new ethnic group as the primary minisry in the facility. Grace Chinese\Bethany, Elmhurst; Asihrwad\St. Paul, Floral Park; Latino ministry\Salem, Bay Ridge.

Commission For Evangelical Outreach: I believe that these congregations, both strong and "at risk" who are sponsoring, initiating or hosting these ministries offer an incredible bank of experience and opportunity to a synod seeking to live into the Great Commission. It suggests that outreach to new neighbors can be a means for parish growth and vitality. These strategies and ministries must be included in the overall planning of the Commission for Evangelical Outreach. Every effort must be made to include leaders from these established and emerging missions. These ministries are providing leaders, experience, insights for all of our congregations to serve their increasingly global and multi cultural communities.

The ten social ministry organizations on our territory have just formed the Lutheran Services Alliance of New York (LSA-NY) so that as one unified body they can work together and with our congregations in ministry. Lutheran Ministries of Higher Education in New York is going through a review of its ministry. Lutheran Schools Association continues to grow in its ability to help sustain and initiate education ministries. We have the opportunity to organize the fabric of our life together so that congregations can grow through share outreach ministries; programs of social ministry (Zion and Transfiguration in Harlem are looking at the possibility of partnerships with LSS); campus ministry; and schools and early childhood ministries.

Full Communion and Ecumenical Partnerships: Thirteen of these ministries are full communion partnerships or involve pastors from full communion judicatories. They include Pastor Glenn Missick (executive for Black Ministries of the RCA) serving an interim at Abiding Presence, Bronx; RCA partnership in the Latino ministry in Kingston; Episcopal partnership in Amagansset; Presbyterian partnership with Pastor Shin at Reformation Korean inBrooklyn; LCMS partnership at True Light in Chinatown in the Fujianese outreach. Episcopal partners from Trinity, Wall Street and St. Paul's Chapel with Hope mission at Ground Zero.

A Synod in the Breach: When we initiate and support these ministries we also embrace the worlds and issues from which they come. Over 75% of those served in our Latino ministries are undocumented people. Many embraced by these ministries are living in poverty. Economic migration, immigration and refugee issues will be at the center of our concern and public conversation. The Center for Public Theology will be one way for our synod to participate in these issues and the ecumenical and interfaith conversations which will allow theology to shape public life. Support for congregations involved in

church based community organizing, and the Urban Empowerment Fund are important ways for a synod to be "healers of the breach, restorers of streets to live in." (Isaiah 58)

Leadership, Canon 9 and Total Ministry: Most of these ministries are "the road not taken" by most seminarians and pastors. Yet God has provided wonderful grass roots leadership. The leadership for these ministries comes from pastors ordained in other traditions, deacons and synodically authorized ministers raised up by local communities of faith, and Metropolitan New York Synod pastors. Our Latino deacons come from three congregations which are producing wonderful leaders for the entire synod (Cristo, Freeport; Trinity, Sunset Park; Resurreccion, Hempstead). Here are some of them: *Jorge Ospina is a carpenter from Colombia who has served us in Poughkeepsie and now is starting the ministry at St. Luke's in Woodhaven. Most of those he serves are undocumented and from South America. He has been approved for ordination. Pastor Barry Lawless and his wife teach first communion classes to the children. Begun several months ago the ministry averages more than fifty at worship and two Sundays ago had 93 attend liturgy. Jorge carves small crosses, hands them out at the local Laundromat, prays with the people and invites them to the ministry.

*Andrena Ingram is a TEEM candidate nearing ordination. She is a member of Transfiguration, has the HIV virus and is a recovering addict. She shared her story with the Conference of Bishop's at a retreat on poverty. She already has a vibrant ministry to inner city people living in poverty, and living one day at a time.

*Perucy Buttiku began the Swahili ministry with a Bible study for East African women, many of them in neglected or abusive situations. She began the Swahili worship as a deacon and was recently ordained (attended by Anna Mkapa, the first lady of Tanzania). She is leading this East African ministry in "Journey Together Faithfully," the study on sexuality of the ELCA.

Each of these leaders and many more are Diakonia graduates. The need for local leadership is acute in many of our parishes which cannot find or afford full time pastoral ministry. Several mission driven avenues are being explored.

1. The Conference of Bishops has been studying synodically authorized ministries and has concluded that we should embrace the possibility of local ordination similar to Canon 9 of the Episcopal Church. (Actually, Canon 9 has been folded into a more comprehensive canon for ordination which allows for this local possibility.) Our synod and the ministry situations described in this report have been driving this conversation. My position is that the Bishop is the mission director and Word and Sacrament leader in the synod. She should have the discretion to ordain missionary leaders needed for Word and Sacrament ministry in these mission situations. I believe that these local ordained leaders should be ordained in and for the whole church and rostered to place. The "place" of this local rostering could be an ethnic community, a conference, several yoked parishes, a synod. Mentoring, supervision and vocational formation would be ongoing. At some point when candidacy requirements are completed the missionary pastor would be rostered in the whole church. We will be taking this up at our March meeting of the conference.

- 2. Total Ministry is the term used to describe the team of ministers in a congregation, or cluster of congregations. Pastor Rich Hill has been leading us in getting to know this concept which opens the door for a variety of local ministries to lead the church in mission. The Northeast Queens cluster is looking at a Total Ministry model which will have several pastors, a youth and family director, an older adult director and others on a team to serve all the conference congregations as well as the missionary efforts in the neighborhoods. The role of the conference as a platform for mission planning and accountability will be critical to the ministries described in this report.
- 3. The Ministerium last month looked at these issues, as well as a document on ministry in the absence of a presiding pastor, including an order of service for communion by extension. Use of this liturgy by Pastor Peg Wuertele at Redeemer, Queens Village is showing great promise.

Resources: A Mission Society? We are in the midst of a long decline in the traditional sources for funding these ministries. One source is the Division for Outreach of the ELCA. Five years ago their funding (including mission pastor's salaries) was about \$700k. In this present budget they are funding nine ministries at \$157k. Our request for new funding for this coming year is an additional \$110k for six ministries bringing the total to \$267k from national D.O. We anticipate that we will not get the total requested. Figure around \$225k from the ELCA. Add in about \$70k for funding for Daniel Peter which we also receive from D.O. That means that in five years our national funding has decreased by almost 50%

Five years ago our synod was budgeting about \$60k for our outreach ministries (our synod is one of the only ones to fund shared outreach ministries from their own budget). Currently we are funding 16 ministries for \$185k from our synod budget. Add in about \$25k to make up for funding requested which we will not get from D.O. and you have the picture. We have increase our local funding of these ministries in five years from \$60k to \$215k at a time when our synod mission support from congregations has been decreasing for the past five years. Our annual deficits of \$200\250k are almost the exact amount of the budgeted synod support for these ministries.

A good sign is that it appears that for the first time in several years our mission support will be more than last year. Another critical source of funding is for the mission leaders of our staff. David Anglada's salary is paid by the national Division for Outreach; much of the international travel for Gary Mills is funded outside of our budget. Outside grants pay for all of Lily Wu's stipend and pick up some of Tony Aguilar's renumeration as well.

In recent years thirteen supported ministries have gone off partner support. In 2005 Cristo Freeport will also be on their own. This does not mean that support for tese ministries does not continue to happen. Local conferences, the Bishop's Discretionary and Mission funds and other grants and local partnership continue all the time.

It is clear that in the future we are going to have to take primary responsibility for maintaining these ministries and starting new ones. I would like to dream with you about starting a Missionary Society among us to nurture these ministries, train and maintain these leaders, seed congregation outreach through the Commission for Evangelical Outreach, maintain our strong companion synod relationship. Perhaps now is the time to think about undergirding these ministries with a capital fund raising effort.

In the following pages will be snapshots of each of these ministries, lists of ministries funded by synod and national Division for Outreach, churches which have gone off partnership support, full communion partnerships, new ministries started during my term as bishop, and congregation partners (including congregations at risk) for these ministries. What I hope has been conveyed is that this is not a report about "them," but a report about what we are becoming together as a synod. We are being changed as much as the church in the time of Peter and and Cornelius is being changed. Our new Lutherans are bringing renewed vigor in evangelism, witness to the power of Jesus in their lives, a love of the Bible. South Asian and Korean evangelists canvass the neighborhood for a new suburban ministry. Chinese members are seeking to bring Bibles back to their homeland. Revivals are springing up throughout the synod. Support of these ministries is a sign of hope for the future of the Lutheran family in this incredible metropolis. All our parishes were begun by newcomers to this Mars Hill called New York. May it continue to be true among us as we live every day into a Great Commission Synod.

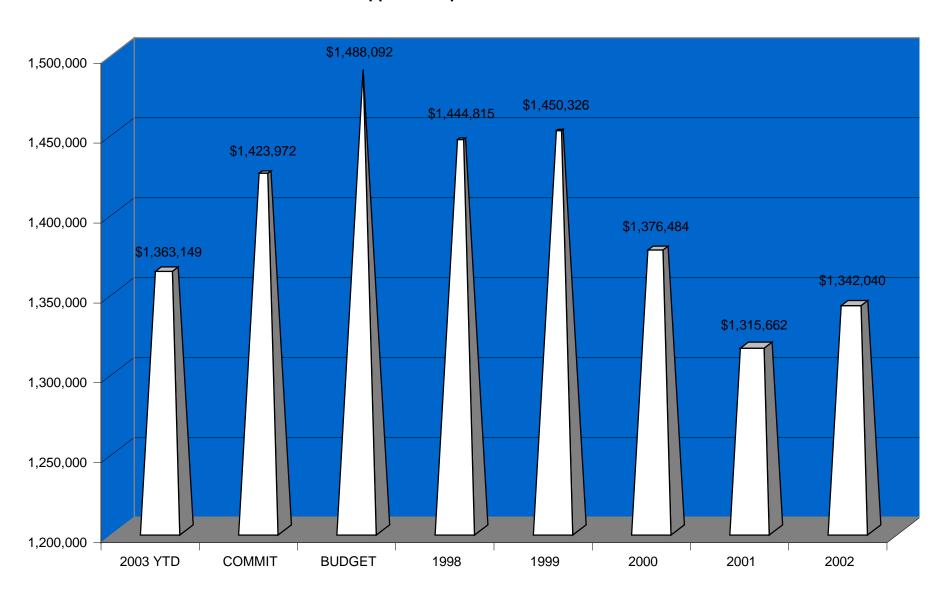
