#### I. CALL TO ORDER

The meeting was called to order at 5:08 pm

IV. MINUTES, January 18, 2004, consideration of

The minutes were approved with one correction in the Report of the Women of the ELCA: the date for their annual synod convention is on September 17

#### V. REPORT OF THE BISHOP

A. Comments on the sexuality study.

- 1. The Listening Post, held in three sessions on March 10, was a well-designed process. It was designed and facilitated by a conflict resolution team from Eastern Mennonite University. The bishop thanked Pastor Gary Mills and all others who were involved in organizing it.
- 2. The Conference of Bishops has been wrestling with the report of the ELCA Task Force on Sexuality. It has not come to consensus on the issues but recognizes the need to move forward with some kind of progress and keep the church united.
- 3. As Region 7 representative on the Churchwide Council, Bishop Bouman will have more to say on this later in the agenda.
- B. The St. Olaf Concert was a success. About \$18,000 will be realized for the synod.
- C. Bishop Bouman discussed with Presiding Bishop Mark Hanson, the following apportionment of the MNYS tithe of legacy money to the ELCA and asked for council's blessing. These would benefit both the wider church and the Metropolitan New York Synod:
  - 1. Fund for Leaders in Mission (to benefit MNYS candidates for ministry)
  - 2. Ethnic mission strategies
  - 3. Lutheran Schools Association to underwrite a director for developmentally disabled
  - 4. Lutheran Immigration and Refugee Services for the creation of an immigration task force in every synod so that there is a national as well as a local network. A motion for the creation of these task forces in every synod will be proposed to the Churchwide assembly by the Minnesota Synod. This resolution will come to our Synod Assembly in May.

RESOLUTION OF SUPPORT: RESOLVED, the Metropolitan New York Synod Council commends the vision developed by Bishop Bouman in consultation with Presiding Bishop Hanson for directing our tithe to the ELCA toward the areas of Leaders in Mission, Ethnic Specific Strategies, Lutheran Schools Association, and Lutheran Immigration & Refugee Service.

#### **ADOPTED**

D. Mission Development Board (MDB)

The Mission Planning Team (a component of the MDB) meets again on March 16. It consists of those deans who are working with Pastor Gary Mills on the vacancy process (Pastors Brooke Swertfager, Richard Mueller, Frank Nelson, and Gary Schulz) and three CEO task force leaders (Dcn. Gale Ruege, Pr. Barrie Lawless, and Pr. Richard Hill). They are studying the new process and its relationship to the existing (and continuing) process managed by the Office of the Bishop.

#### F. Calls

ACTION (SC05/3:1) RESOLVED that Synod Council call the Rev. Annemarie Noto as part-time interim pastor at St. David's, Massapequa Park, effective February 1, 2005.

#### G. Staff reports

The Rev. Robert Wollenburg, Assistant to the Bishop for Giving, distributed a report entitled "ELCA & MNYS Mission Support for 2004". (Exhibit A). Congregations have been working hard on mission support but despite this hard work our mission support trends downward. There are still a number of our congregations who pledge nothing to the synod. Pastor Wollenburg encouraged intentional ministry in the practice of stewardship.

#### H. Ballot for Churchwide Voting Member (clergy)

Mr. Litke reported the nominees received to date and placed them in nomination. No additional names were offered. Nominees: Katrina Foster, Martin Hauser, Leo (Jay) Longan, Annemarie Noto, Daniel Peter, Gary Schulz, Eric Swensson, Phil Trzynka, Diane Wildow. Pastor Gary Schulz was elected on the fourth ballot. Pastor Annemarie Noto will be first alternate.

#### VI. REPORT OF THE TREASURER

Mr. Robert Buescher

- A. Financial Report. Mr. Buescher reported that the trends are not encouraging in the long term. Mission support continues its downward trend.
- B. 2006 Budget Draft

The proposed 2006 Budget is out of balance, but transfer of funds can compensate for the deficit. However, if transfers continue at current levels, unrestricted funds will be depleted by the end of 2006.

March 15, 2005

The bishop announced that, given the numbers presented in the budget, it will not be possible to fill the full-time staff vacancy left by Pastor Cherlyne Beck's departure. This places an additional burden on the remaining staff and others, but it is currently necessary so that we can continue to support the many ministries of our synod. We need to face up to our responsibilities to our mission.

Time was requested for further discussion of the budget at the next meeting so that members of the council may better understand it.

## ACTION (SC05/3:2) RESOLVED that synod council approve the budget draft for FY2006 (with permission for the Financial Management Committee to make adjustments) ADOPTED

#### D. Comments by Bishop Bouman

Bishop Bouman expressed dismay at not being able to fill Pastor Beck's position. He is disheartened to see staff that is over burdened and he is disheartened on behalf of the support we are trying to give to the ministries of our synod. He addressed the deeper spiritual issue of declining mission support in a place where God has richly blessed us. He will speak directly and honestly about this to our synod assembly in May.

Lay people as well as clergy have responsibilities for our stewardship. It is time for all of us to feel the pain together.

#### VII. DEANS REPPORT

The Rev. Gary Schulz

Pastor Schulz noted the positive attitude of the deans resulting from their added responsibilities and strengthened relationship with the bishop and staff. Stewardship took the lion's share of time in today's meeting. Among the suggestions coming out of this discussion was a suggestion for a bylaw change saying that congregations that do not give to the synod and pastors who do not hand in their annual reports lose voice and vote at the synod assembly.

Of growing concern is the disconnect between pastors, congregations, and the synod.

March 15, 2005

Pastor Schulz noted the added involvement in the vacancy process which will hopefully help with some of this disconnect. The deans' goal is to bring all of our congregations into active participation in the synod. Pr. Schulz lifted up Pr. Mills, who is always there to encourage the deans.

Secretary James Krauser

The review panel submitted corrections, which have been made.

### ACTION (SC05/3:3) RESOLVED that synod council approve the 2004 Synod Assembly minutes.

Secretary Krauser noted that at some point synod council needs to make a decision as to whether we need to provide bound minutes or if we can just provide them electronically. He noted the cost savings of doing them electronically. This will be brought up at the April meeting. We will have to produce some printed copies for the ELCA and/or cd rom versions in addition to electronically available copies.

#### C. Sexuality Report

Synod Council resolved to meet as a committee of the whole to discuss the four resolutions presented for consideration. All four resolutions are similar in focus:

- Trinity Evangelical Lutheran Church of Manhattan/Iglesia Luterana Trinidad submitted by the congregation council – Exhibit F
- Trinity Lower East Side Lutheran Parish submitted by the congregation council
   Exhibit G
- Resolution submitted by the Rev. James Krauser and the Rev. William Baum –
   Exhibit H
- Members of the Manhattan Ministerium (the Rev. Amandus Derr's name to be added to signators) **Exhibit I**

After considerable discussion as a committee of the whole, the committee of the whole recommended that **synod council forward the resolutions to Church Council as information with a cover letter.** Bishop Bouman commented that the Churchwide Council is not looking for finely crafted resolutions from synods upon which they would make their recommendation to the Churchwide Assembly; they are simply looking for information. Individual opinions offered to the bishop in writing were also distributed to the synod council for their information. (**Exhibit J**)

#### D. Synod Assembly

- 1. Update: Seventy-seven people are registered to date. Marriott will not offer the lower housing rate after April 15.
- 2. Site Selection for 2006:

Site selection committee consists of the Revs. Fred McElderry, Jack Malfati, and Gary Mills. They looked into several churches, motels and other institutions for our three-day assembly in 2006. Only three of our churches are large enough: Grace Yorktown Heights, St. Peter's Huntington Station, and St. John's Poughkeepsie. Grace could not accommodate more than 550, so visitors would have to be in a separate room with closed circuit television. They also considered the Nassau Coliseum in Uniondale, the Marriott in Brooklyn, the Sheraton in Poughkeepsie, Jacob Javits Center, and Wagner College. When all was said and done and cost, proximity, and available dates were considered, the committee recommended St John's Poughkeepsie for site and worship.

ACTION (SC05:3/5): RESOLVED that the MNYS 2006 Synod Assembly be held at St. John's Lutheran Church in Poughkeepsie for worship and plenary and that the local Sheridan will be used for sleeping accommodations.

Mr. Charles Kalhorn, Treasurer

- LMM accepted the challenge to meet goals for a grant. LMM-NY needed to become self-incorporated to apply for these monies. Mr. Kalhorn distributed a resolution to the Division for Congregational Ministries, ELCA, regarding their incorporation.
- Permission was requested to conduct an appeal to congregations and individuals in support of the LMM Endowment Fund. This is a preliminary request, there is no date yet set for the appeal. Permission was granted. (See **Exhibit K**) for the form they will be using
- National LMM Assembly is coming up in Charleston, SC. Last year 750 men participated.
- Mr. Bill Wooten, LMM vice president, reported on LMM's recent annual meeting. Fifty-eight were in attendance. Mr. Kalhorn was re-elected as treasurer, along with two mission leaders. He expressed thanks to the speaker, Pastor Bob Wollenburg.
- Mr. Kalhorn made the council aware of the Spanish translation of the Master Builder's Bible and gave copies for the synod office

#### B. Women of the ELCA

- Ms. Gray highlighted the upcoming Triennial in San Antonio, TX. More information is on the Women of the ELCA website
- Synodical annual convention is on September 17 at Grace, Yorktown Heights. Brenda Smith will preach.
- Super Saturday will be on April 16 at The Wartburg, Mt. Vernon. It will be a celebration of women, with each congregation invited to nominate one woman from their congregation to be honored that day. Thelma Thomas, a Biblical storyteller, will be the presenter.

## TRINITY EVANGELICAL LUTHERAN CHURCH OF MANHATTAN IGLESIA LUTERANA TRINIDAD RESOLUTION OF THE CONGREGATION COUNCIL REQUESTING ACTION BY THE SYNOD COUNCIL

- WHEREAS, Trinity Evangelical Lutheran Church of Manhattan, a congregation of the Metropolitan New York Synod of the Evangelical Lutheran Church in America (ELCA), has fully welcomed lesbian, gay, bisexual, and transgender people for the past two decades; and
- WHEREAS, Trinity Evangelical Lutheran Church of Manhattan provided a place of pastoral and material comfort for people dying from and living with AIDS from the earliest days of the epidemic, when many were denied full care because of their sexual orientation; and
- WHEREAS, Trinity Evangelical Lutheran Church of Manhattan has for several years been a Reconciling in Christ Congregation, and as such welcomes all people, including gay, lesbian, bisexual, and transgender individuals and couples as fully participating members of our ministry; and
- WHEREAS, Trinity Evangelical Lutheran Church of Manhattan affirms that bisexual, transgender, lesbian, and gay people are regularly at risk of physical, emotional, and spiritual harm when policies, institutions, and cultural assumptions discriminate against them in favor of heterosexuals; and
- **WHEREAS**, Trinity Evangelical Lutheran Church of Manhattan believes that churches gravely damage transgender, bisexual, lesbian, and gay people when they refuse to bless people in committed same-sex relationships and refuse to approve and call candidates who are in them; and
- **WHEREAS**, Trinity Evangelical Lutheran Church of Manhattan desires that the Evangelical Lutheran Church in America recognize the precious gifts that its gay, lesbian, bisexual, and transgender members have to offer as lay members and as rostered leaders; and
- WHEREAS, the Church Council of the Evangelical Lutheran Church in America, to which the Metropolitan New York Synod Council relates, will consider at its regular meeting on April 8-11 the "Report and Recommendations of the Task Force for ELCA Studies on Sexuality" in preparation for the 2005 Churchwide Assembly,
- **NOW, THEREFORE, BE IT RESOLVED**, that the Congregation Council of Trinity Evangelical Lutheran Church ("the Congregation Council") REQUESTS the Metropolitan New York Synod Council ("the Synod Council") take the following TWO actions in response to the aforesaid "Report."
- **ACTION 1**: The Congregation Council requests that the Synod Council consider and pass the following resolution, in these words or others to similar effect:
  - "BE IT RESOLVED, that with regard to candidacy processes for rostered persons, it shall be the policy of the Metropolitan New York Synod of the Evangelical Lutheran Church in America to approve and call partnered gay and lesbian candidates who are otherwise in compliance with Vision and Expectations; and be it further
  - RESOLVED, that with regard to discipline processes for rostered people and congregations, it shall be the policy of the Metropolitan New York Synod of the Evangelical Lutheran Church in America to refrain from disciplining partnered gay and lesbian people who have been so approved and called and the congregations that call them."
- ACTION 2: The Congregation Council requests that the Synod Council consider and pass the following resolution, in these words or others to similar effect, and that, pursuant to §14.21.11 of the

Constitution of the Evangelical Lutheran Church in America, the Synod Council transmit such resolution to the Church Council of the ELCA in time for that Council's meeting of April 8-11, 2005:

- "BE IT RESOLVED, that the Metropolitan New York Synod believes that Recommendation Three of the Task Force for ELCA Studies on Sexuality strikes a necessary balance between those who favor the approval and call of candidates who are in committed same-sex relationships; and be it further
- RESOLVED, that the Metropolitan New York Synod expresses its concern that Recommendation Three may create confusion in that it affirms a disciplinary policy that excludes people in committed same-sex relations from rostered ministry yet permits synods and congregations not to enforce this policy; and be it further
- RESOLVED, that the Metropolitan New York Synod recognizes that some synods and congregations do and will want to approve and call people in committed same-sex relationships, while other synods and congregations do not and will not want to approve and call them; and be it further
- RESOLVED, that the Metropolitan New York Synod asks that the Church Council of the Evangelical Lutheran Church in America recommend the following changes for the approval of the 2005 Churchwide Assembly, in order to allow the church to remain together even while disagreeing:
  - (A) The sentence in Guidelines for Discipline currently reading 'Practicing homosexual persons are precluded from the ordained ministry in this church' will read: 'Although some synods and congregations will approve and call people in committed same-sex relationships and some synods and congregations will not, people in heterosexual and homosexual relationships will be held to the same standards of sexual conduct for the rostered ministries of this church.'
  - (B) The sentence in Vision and Expectations currently reading 'Ordained ministers who are homosexual in their self-understanding are expected to abstain from homosexual sexual relationships' will read 'All ordained ministers, whatever their sexual self-understanding, will honor the gift of sexuality in accordance with standards of this church'; and be it further
- RESOLVED, that the Metropolitan New York Synod asks that the Church Council of the Evangelical Lutheran Church in America develop and recommend for the approval of the 2005 Churchwide Assembly of standardized policies detailing the chaste and faithful behaviors that are expected of all rostered leaders regardless of whether that person is heterosexual or homosexual."



#### A Resolution to Commend the Task Force for ELCA Studies on Sexuality

- The Metropolitan New York Synod Council expresses its appreciation and thanks for the work of the Task Force in assisting this church in discerning the witness of the Gospel of Jesus Christ as we prayerfully seek the Spirit's guidance in addressing the lives and service of faithful gay and lesbian Christians.
- The Metropolitan New York Synod Council supports wholeheartedly the Task Force recommendation that in the midst of our disagreements we remain committed to living together believing that Christ calls us to be faithful to each other. We are grateful for the Biblically-based study process that engaged us together in building up the Body of Christ.
- The Metropolitan New York Synod Council appreciates the sensitivity to all parties embodied in the recommendation that appropriate iprayerful supportion of same-sex couples continue to be a matter for pastoral discretion.
- The Metropolitan New York Synod Council supports the recommendation that this church need not always seek to administer discipline where a committed partnered gay or lesbian rostered person is called to or engaged in faithful ministry to the Gospel of Jesus Christ.
- The Metropolitan New York Synod Council favors language in <u>Guidelines for Discipline</u> and <u>Vision and Expectations</u> which would clarify and guide the recommendation that pastoral discretion may be used with regard to the discipline of partnered gay or lesbian rostered persons. This clarity could be provided by revising the sentence

iPracticing homosexual persons are precluded from the ordained ministry of this church.î

in *Guidelines for Discipline* along these lines:

iHomosexual persons whose sexual conduct is deemed to be incompatible with the standards for rostered ministers of this church shall be subject to the discipline of this church.î

and by revising the sentence in *Visions and Expectations* 

*iOrdained ministers who are homosexual in their self-understanding are expected to abstain from homosexual sexual relationships.î* 

in the following (or some similar) way:

iOrdained ministers who are homosexual in their self-understanding are expected to honor the gift of human sexuality and the standards of this church taking care not to be a stumbling block to the faith of others.î

We believe these suggested revisions will enable the third of the Task Forceís recommendations, foster an atmosphere of trust, and continue our process of dialogue and discernment under the guidance of the Holy Spirit.

#### **BACKGROUND: TEXTS AT ISSUE**

#### **Task Force Report**

#### Part One: Recommendations

The Task Force for ELCA Studies on Sexuality recommends that the Evangelical Lutheran Church in America continue under the standards regarding sexual conduct for rostered leaders as set forth in Vision and Expectations and Definitions and Guidelines for Discipline, but that as a pastoral response to the deep divisions among us, this church may choose to refrain from disciplining those who in good conscience, and for the sake of outreach, ministry, and the commitment to continuing dialogue, call or approve partnered gay or lesbian candidates whom they believe to be otherwise in compliance with Vision and Expectations and to refrain from disciplining those roster people so approved and called.

#### Part Two: Rationale for Task Force Recommendations

Therefore, though our recommendations do not establish new policy or change existing policy, the do appeal for respect for one anotheris bound consciences as a matter of pastoral concern

#### Vision and Expectations: Ordained Ministers in the ELCA

**Sexual conduct.** The expectations of this church regarding the sexual conduct of its ordained ministers are grounded in the understanding that human sexuality is a gift from God and that ordained ministers are to live in such a way as to honor this gift. Ordained ministers are expected to reject sexual promiscuity, the manipulation of others for purposes of sexual gratification, and all attempts of sexual seduction and sexual harassment, including taking physical or emotional advantage of others. Single ordained ministers are expected to live a chaste life. Married ordained ministers are expected to live in fidelity to their spouses, giving expression to sexual intimacy within a marriage relationship that is mutual, chaste, and faithful. Ordained ministers who are homosexual in their self-understanding are expected to abstain from homosexual sexual relationships.

#### **Definitions and Guidelines for Discipline of Ordained Ministers**

#### **Sexual Matters**

The biblical understanding which this church affirms is that the normative setting for sexual intercourse is marriage. In keeping with this understanding, chastity before marriage and fidelity within marriage are the norm. Adultery, promiscuity, the sexual abuse of another, or the misuse of counseling relationships for sexual favors constitute conduct that is incompatible with the character of the ministerial office. Practicing homosexual persons are precluded from the ordained ministry of this church.

Whereas, we believe inequitable legislative restrictions do not allow for full respect of this diversity and hinder the integrity of our witness in seeking ways to live together faithfully in the midst of our disagreements, and

Whereas, we value the good order of the church and desire to be in compliance with policies and procedures of the ELCA:

*Be it resolved* that the undersigned rostered leaders of the Manhattan Ministrium request the Metropolitan New York Synod Council convey to the

ELCA Council our desire of a recommendation to the 2005 ELCA Churchwide Assembly that calls for the *development of standardized policies detailing the chaste and faithful behaviors that are expected of all rostered leaders* regardless of whether that person is heterosexual or homosexual.

I am writing to you to express my concerns over the recommendations from the Sexuality Study Task Force that will go to the assembly of our national church body in August. I am concerned that by not adopting resolutions with clear lines, the present situation in our church will not change much. There will still be areas of our church where those in same-sex relationships will not be welcomed. Living in the Metropolitan New York area affords us many luxuries. One of the luxuries is that we are able to seek out and belong to an ELCA congregation that welcomes people that are gay/lesbian and will make them feel welcome if they are in a relationship with someone of the same sex. Notice, I say a luxury. That is unfortunate. It should not be a luxury, it should be a given. It will not be a given if the ELCA does not adopt policies that provide that peace and security to gay and lesbian people. My partner Frank and I are welcome at Our Savior's in Glen Head. Our Savior's recently adopted an Affirmation of Welcome whereby they state that all are welcome regardless of sexual orientation. I am concerned that when the day comes that Frank and I must leave this area that we will not find another ELCA congregation to welcome us. If the ELCA does not adopt policies that assure this, our search would be unduly difficult.

I am also concerned that roughly 42% of those responding to the Task Force who were 24 years old or younger were in favor of blessing and rostering. The recommendations being presented to the Assembly are not recommendations that suggest policy change across the board that would endorse blessing and rostering. This age group is the future of our church. If we adopt policies that do not address the hearts and minds of our future, we are headed for trouble.

Many say that they fear that this will cause a split in our church. I think that by adopting "don't ask, don't tell" policies, we are in fact creating breeding ground for a split. There will be those synods and congregations that will bless and roster and those that will not. This sounds like two different churches to me.

I sincerely thank you for allowing me to voice my concerns for a church that I love.


### **ELCA Bishops Hear Concerns, Surplus News From Presiding Bishop**

DALLAS (ELCA) -- While expressing gratitude for leaders in the church who prepared the report and recommendations on homosexuality released Jan. 13, the presiding bishop of the Evangelical Lutheran Church in America (ELCA) raised some concerns about the recommendations in his report to the ELCA Conference of Bishops.

The Rev. Mark S. Hanson also told the conference that the ELCA churchwide organization finished the 2004 fiscal year with a net surplus.

The ELCA Conference of Bishops is an advisory body of the church, consisting of the 65 ELCA synod bishops, ELCA secretary and ELCA presiding bishop. It met here March 3-7. A key part of the conference's work at this meeting was developing a response to



the report for the church, as the ELCA prepares to discuss homosexuality issues at the 2005 Churchwide Assembly in Orlando, Fla., Aug. 8-14.

The report, the result of three years' work by a task force, included three recommendations for the assembly to consider when it is expected to answer two key questions on homosexuality: Should the church bless same-gender relationships? Should the church allow people in such relationships to serve as professional lay and ordained ministers?

The task force recommended that the ELCA:

- + concentrate on finding ways to live together faithfully in the midst of disagreements.
- + continue to respect the pastoral guidance of a 1993 statement of the ELCA Conference of Bishops opposing the blessing of homosexual relationships but remaining open to pastors wanting to provide pastoral care for gay and lesbian Lutherans.
- + continue under current standards that expect unmarried ministers to abstain from sexual relations, defining marriage as being between a man and a woman; but, respecting the consciences of those who find these standards in conflict with the mission of the church, the ELCA may choose to refrain from disciplining gay and lesbian ministers in committed relationships and from disciplining those who call or approve partnered gay or lesbian people for ministry.

In his report, Hanson offered his first public comments on the task force report and recommendations. Hanson said:

+ Two "hermeneutics" or paradigms are at work among the members of the ELCA that make agreement difficult on scriptural and theological matters. The Rev. Craig L. Nessan, academic dean and

professor of contextual theology, Wartburg Theological Seminary, an ELCA seminary in Dubuque, Iowa, writes that there is a "traditional approach" and a "contextual approach" in interpreting Scripture, both of which are valid and irreconcilable, Hanson told the bishops. Similarly, Dr. Marcus J. Borg, Department of Philosophy, Oregon State University, Corvallis, writes that there are two irreconcilable "paradigms" in which Christians differ in their understandings of the Christian tradition and their interpretation of Scripture, creeds and the confessions, he said. Hanson said he's heard people with different understandings of Scripture and theology seeking to find a place for their views in the sexuality recommendations.

"Do we expect a resolution to provide a bridge between two extremes?" Hanson asked the bishops. "We Lutherans have come to say that when something is 'paradoxical' that we're going to live in the paradox at the foot of the cross and not force ourselves to decide it with a vote."

+ Hanson said he has "increasing concerns" about Recommendation 1, which calls on the ELCA to concentrate on finding ways to live together faithfully in the midst of disagreements. The recommendation seems to be causing some confusion for some, and the conversation seems to be about much more than the task force intended, he said. For example, Hanson said some have "perceived" that what is at stake is the unity of the "Church catholic," not just the ELCA.

"I have great concerns about a church body voting on the unity of the Church," he said. "The unity of the Church is God's gift to us. We are not to create the unity of the Church. Wouldn't it be better to remind ourselves of the unity we are given but not to ask us to vote on the unity of the Church?"

Hanson also said he hopes no one will leave the ELCA over decisions on homosexuality. He reminded the bishops that if some members do leave "we are still brothers and sisters in Christ. There's where I think Craig Nessan is helpful in trying to say, 'let's not go the secular route of schism but let's look at the continuum of the way we relate," he said in an interview with the ELCA News Service.

Finally, Hanson said he is concerned that a vote on church unity could become a "church-defining, church-dividing" issue, and a conversation about that should take place in the "context of the Lutheran World Federation (LWF)." The LWF is a global communion of 138 member churches in 77 countries, representing 66 million Christians worldwide. Hanson -- who is also LWF president -- suggested concepts used in ecumenical discussions such as "reconciled diversity" and "differentiated consensus" might be helpful in such discussions.

+ Hanson said he has heard many concerns about Recommendation 3, which suggests that for reasons of conscience the ELCA may choose to refrain from disciplining gay and lesbian ministers in committed relationships and from disciplining those who call or approve partnered gay or lesbian people for ministry. "For many people [this] is not only confusing but seems to lack integrity because it is read as at least a change in practice if not in policy," he said in an interview.

As an alternative Hanson said it may be helpful to "test" some language that could provide for a special roster, ordination to a specific place or synodically authorized ministry to allow people who are gay and lesbian and in committed relationships to serve as professional church leaders. The presiding bishop suggested the possibility of a six-year testing period.

If the church wanted to test such a system, it would require a "significant standing down" from people who are gay and lesbian, many of whom view such a system as "second class" and unjust, he said. People who view Scripture traditionally would also have to stand down to allow "space," he said.

Presiding Bishop Addresses Budget Surplus, Jerusalem Hospital Situation Hanson said the ELCA churchwide organization finished the 2004 fiscal year with a \$4.5 million

net surplus. Hanson credited the Conference of Bishops for "making tough decisions" and the churchwide staff for significant underspending in creating the surplus. He said he will likely have a specific proposal for use of the funds for the ELCA Church Council to consider when it meets in Chicago next month.

The conference heard details of a proposed ELCA strategy on the Middle East, tentatively called "Hope in the Holy Land: Pray, Tell, Act for Peace With Justice." In 2004 the ELCA Church Council asked the ELCA Division for Church in Society and ELCA Division for Global Mission to develop the strategy.

One component of the proposal addresses concern for Augusta Victoria Hospital, an LWF-operated hospital on the Mount of Olives in East Jerusalem, which serves Palestinians. The hospital has been involved in a longstanding tax case brought by the State of Israel that could require it to pay an employer's tax. The cost of such a tax may force the hospital to curtail operations.

"It's time to turn up the heat," Hanson told the bishops, saying Lutherans need to press the U.S. government to intervene with Israel on the hospital's behalf. He proposed sending an "e-letter" to professional church leaders asking them to write to U.S. Secretary of State Condoleezza Rice, and members of Congress to "exert pressure" on the State of Israel.

"This is clearly a humanitarian issue," he said.

### ELCA Bishops Send Message To Church On Sexuality Recommendations

DALLAS (ELCA) -- The Conference of Bishops of the Evangelical Lutheran Church in America (ELCA), acknowledging its members are "not of one mind" on issues related to homosexuality, sent a message to the church at the conclusion of its spring meeting here. The conference urged the church to affirm two recommendations resulting from a three-year study on homosexuality conducted by a task force of the church, but could offer no definitive advice on the most controversial of the three recommendations.

The ELCA Conference of Bishops is an advisory body of the church, consisting of the 65 ELCA synod bishops, ELCA secretary and ELCA presiding bishop. It met here March 3-7.

The report and recommendations, released Jan. 13, provides possible answers to two key questions on homosexuality: Should the church bless same-gender relationships? Should the church allow people in such relationships to serve the church as professional lay and ordained ministers?

The task force recommended that the ELCA:

- + concentrate on finding ways to live together faithfully in the midst of disagreements. The Conference of Bishops called on the church to affirm this recommendation. "We understand that this recommendation commits us to continuing our journey together for the sake of God's mission," the bishops' message said.
- + continue to respect the pastoral guidance of a 1993 statement of the ELCA Conference of Bishops opposing the blessing of homosexual relationships but remaining open to pastors wanting to provide pastoral care for gay and lesbian Lutherans. The bishops asked the church to affirm the 1993 statement "leaving it as it was intended -- a matter of advice and counsel," the message said.
- + continue under current standards that expect unmarried ministers to abstain from sexual relations -- defining marriage as being between a man and a woman -- but respecting the consciences of those who find these standards in conflict with the mission of the church, the ELCA may choose to refrain from disciplining gay and lesbian ministers in committed relationships and from disciplining those who call or approve partnered gay or lesbian people for ministry.

"We acknowledge that as a conference we are unable to offer a definitive word of advice on recommendation three," the Conference of Bishops said. "Some bishops are convinced there should be no change in the practice and policy of our church. Other bishops favor changes both in policy and in practice though there is no consensus as to how such changes should take place."

The bishops acknowledged their differences on homosexuality. "We hold each other in love and respect. We recognize that our differences are rooted in deeply held convictions. We honor the integrity of these convictions of conscience and faith 'with all humility and gentleness, with patience, bearing with one another in love, making every effort to maintain the unity of the Spirit in the bond of peace

(Ephesians 4:2-3)," the message said.

"For the sake of the unity of this church and its mission, we are not divided by these differences," the message said. "As evidence of this, we point to the extraordinary engagement of this church in God's mission in the world and our full participation in that work. We thank God for this."

The Conference of Bishops' message said they "see throughout this church that a commitment to the authority of Scripture is not solely the concern of those who seek to maintain the tradition. Similarly compassion for gay and lesbian persons and a commitment that they be treated justly are not solely concerns of those advocating change."

Between now and the churchwide assembly, the conference called on ELCA members to unite in prayer, read Scripture and Luther's Large Catechism, participate in weekly worship, study theology, practice forgiveness, invite people to a faith community, and "serve and love in Christ's name."

"We understand in all of this that we have responsibility for the stewardship of the unity given to us by the Lord Jesus Christ. We also understand that we exercise that stewardship with brothers and sisters of the whole Church throughout the world," the message said.

"We further understand that we have a responsibility for protection of the most vulnerable. This includes not only the poor, the widow, the orphan, and the stranger, but also all who feel estranged by virtue of their deeply held convictions," the message concluded.

The one-page message was intended to advise the boards of the ELCA Division for Church in Society, ELCA Division for Ministry, and the ELCA Church Council, as each considers what to do with the task force report and recommendations on homosexuality. Eventually, the report and its recommendations, along with proposals on how to consider the issues, will make their way to the 2005 ELCA Churchwide Assembly, Aug. 8-14, in Orlando, Fla.

#### Long Hours to Craft Message

The Conference of Bishops debated and discussed the task force recommendations over several hours during their meeting here. Those sessions included a two-and-one-half hour closed, off-the-record session March 6; an unplanned, informal two-hour writing session the same day attended by more than 40 bishops; and more than two hours of debate and discussion March 7 before the conference adopted the statement by consensus and adjourned.

The bishops took a series of "straw" votes, intended to determine the possibilities, if any, on which they could agree regarding recommendation three. For example, by a vote of 36-22, the bishops present favored that there be no votes taken at the churchwide assembly on sexuality issues. On another possibility, they narrowly favored by a vote of 36-26 all three recommendations provided there were a series of precise "exception" procedures that would allow people who are gay and lesbian and in committed relationships to serve as professional lay and ordained leaders. On still another possibility, the bishops favored 29-26 possible legislative language that would create a "provisional" clergy roster, which would limit the types of service for which these leaders would be eligible.

"The third recommendation ... is so problematic for us," said the Rev. E. Roy Riley, bishop of the ELCA New Jersey Synod, Hamilton Square, and chair of the Conference of Bishops, in an interview with the ELCA News Service. Many conference members seemed willing to create "space" for people who are gay and lesbian and in committed relationships to serve as professional lay and ordained leaders, but "there's simply no consensus on how that might be done," he said.

"There are, of course, members of the conference who believe that we would be better off not creating any space whatsoever and would be more affirming of simply continuing the welcoming kind

of stance that we have been in for gay and lesbian persons in the church," Riley added.

Calling the message "significant" for the conference, Riley said he believes the bishops' struggle was similar to what the voting members will experience at the churchwide assembly in Orlando.

"It will just be a much larger gathering. But I think there's a lot of trust ... and confidence in the Spirit's work among the people of God as they gather in assembly in Orlando," he said.
