V. SPECIAL GUEST

Mr. Howard Capell, Esq. reviewed the holdings in the cases litigated between the unauthorized person claiming to be a pastor at St. Peter's in Brooklyn and the synod. He stressed the importance the governing documents played in this case and how critical it is for churches to have access to their governing documents.

VI. REPORT OF THE BISHOP

Pastor Gary Mills reported for the bishop who was at a meeting with the Lily Foundation in Indianapolis.

- A. Comments on issues of the wider church, synod, congregations, and the public arena.
 - 1. The bishop completed his one-on-one visitations with congregation pastors, achieving a 96% completion rate with several meetings still pending due to scheduling conflicts.
 - 2. A consultation process is scheduled to begin at Epiphany, Hempstead. There are three other situations which seem to be heading in this direction.
 - 3. We have several congregations we will be talking with about coming under synod administration. Pastor Mills noted that there are several instances in which congregations have not paid the salary or health care for their pastors for as much as two years or more. We need to be alert to places that are struggling so we can address the situation before it gets this critical.
- B. Mission Development Board (MDB)

The Mission Reinvestment Grant process has been revised. A training meeting will be held for those interested in applying for grants. This process now on a one-year cycle.

Southwest Brooklyn continues in a conversation on the sharing of ministry and resources. These conversations are beginning to produce a helpful conference-wide missional strategy for the conference ministerium.

VII. REPORT OF THE TREASURER – Mr. Robert Buescher

Mr. Buescher reported that the audit is now complete and ready for distribution. It reflects a cash loss of \$50,000 for the last year. This was about the same as the shortfall in mission support.

Mission support contributions are running behind for this fiscal year, as are commitments. This is not uncommon in our experience but both are lagging significantly behind last year.

The usual reports were not available for distribution at the meeting because we have not received final numbers defining our beginning balance for the year from the auditors. Financial reports will be emailed to the members as they are available.

The Planning Team has not yet submitted an opinion on these proposals.

D. Mission Interpretation Initiative for Expanded Partnerships – The Rev. Robert Wollenburg

Pastor Wollenburg reported on the further development of this initiative and provided a draft budget for this work (**Exhibit E**). The plan calls for an expenditure of approximately \$100,000. Ms. Sarah Gioe has been hired for the purposes of work connected with this initiative. Pastor Wollenburg reviewed the purposes of the various expenditures.

Pastor Wollenburg described a new mission support program for which our synod has been selected as pilot site. The program is called: *"Stories to Tell, Gifts to Share."* (**Exhibit F**) This new program will fit very well into the purposes of our initiative. In January, synod council passed a resolution (SC06.1.1) not to proceed with a capital campaign at this time and that in the interim the synod devise and implement a program to improve communication and relationships with its congregations.

Mr. Buescher addressed how we should fund this work. He recommended reassignment of \$20,000 within our approved budget. The remaining \$80,000 would be drawn in equal proportion from the Bishop's Mission Fund and from the Metropolitan New York Synod Fund (General Fund). Mr. Buescher noted that there has been additional income realized in the MNYS Fund from the sale of stock and that \$40,000 of that income should be assigned to this program.

ACTION (SC06:5/2) RESOLVED that synod council approve the budget plan for the *Mission Interpretation Initiative for Expanded Partnerships* as presented in Exhibit E.

ADOPTED

ACTION (SC05:5/3) RESOLVED that synod council approve the allocation of funds for the *Mission Interpretation Initiative for Expanded Partnerships* with \$20,000 being assigned from within our approved 2006 budget, \$40,000 from the Bishop's Mission Fund, and \$40,000 from the Metropolitan New York Synod Fund.

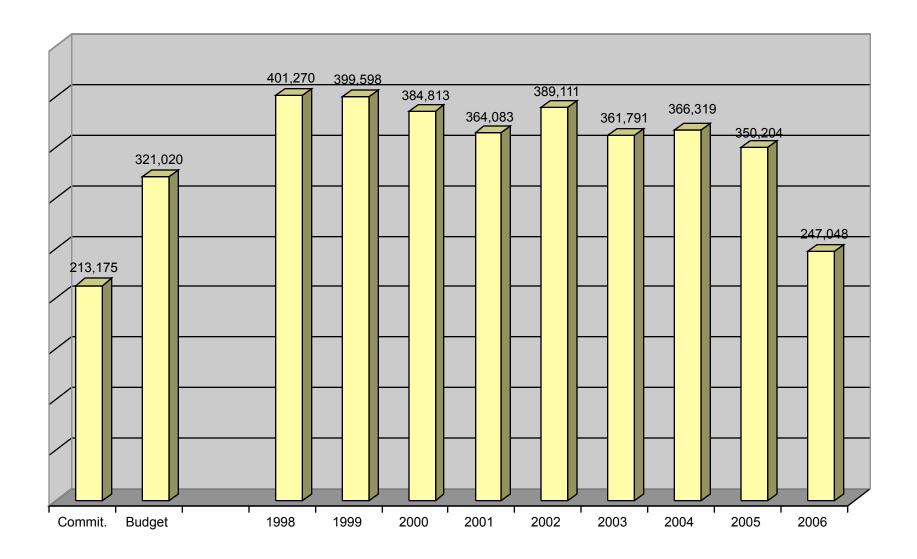

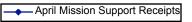

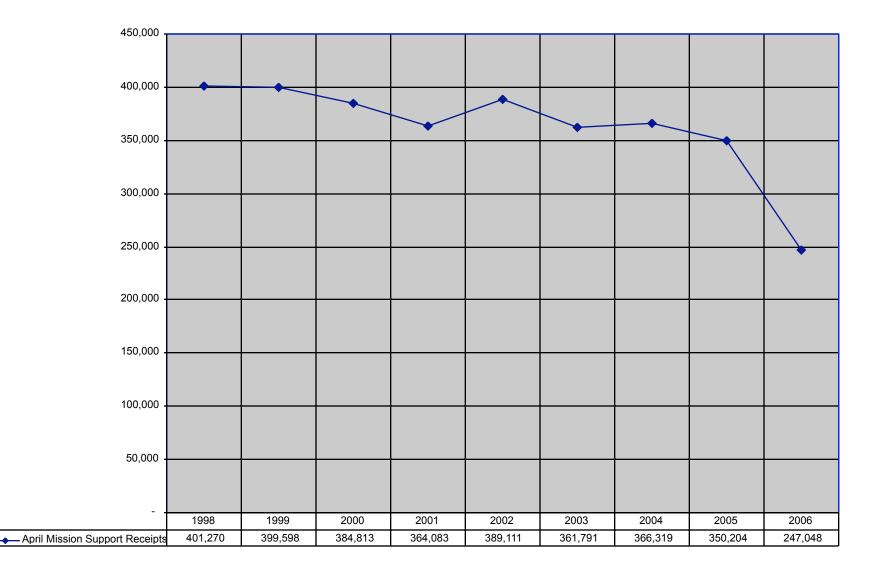

The Diaconate of Metropolitan New York Synod Report for 2006

Calling of the Diaconate

The church continues to be the self-giving servanthood of Jesus in the midst of the world. The presence of a diaconate in the world can help to remind, inspire, organize and lead the church in a renewal of its commitment to servant ministry. The primary area of service is within the congregations and other agencies of our synod. But the total calling and ministry of the deacon is formed by a combination of the needs of our congregations and community, and always with a diaconal focus on doing and enabling servant ministry. The synodical diaconate is also connected to the wider church with a ministry connected ecumenically.

The ultimate purpose for diaconate ministry is mission and outreach—to the poor, the suffering, and those without the Gospel. All of this is dedicated to the memory of the servant Jesus, whose self-giving *diakonia* is at the core of all ordered ministry. As the deacons witness and serve in daily life, the love and ministry of the risen Lord is brought to all that are touched by those ministries.

Mission of the Diaconate Council

The Synod Diaconate Council is established to organize and supervise the overall activities of the diaconate, including reviewing applications and evaluating candidates to be prospective deacons. The goal is to make available for the needs of the wider church a cadre of servants committed to the diaconal outreach throughout the synod and the communities the synod serves. The Council is also responsible for helping to keep the ministries of the deacons connected and serving actively and appropriately. In this regard, under the oversight of the Bishop and in consultation with the congregations they serve, the Council may support and recommend that deacons may be deployed from time to time, to service throughout the Synod.

- □ There are currently 5 candidates who have made application to the Diaconate Council to participate in an internship that might lead to a call as a Synodically rostered deacon.
- A Deacon Retreat was held at Graymoor Retreat Center on March 17, 2006. 38 deacons attended and participated in a discussion of "The Evangelizing Church: A Lutheran Perspective" lead by one of the contributing authors, Dr. Wyvetta Bullock, Executive for Leadership Development in the ELCA. Dr. Bullock was sponsored jointly by the Diaconate Council and the Synod Commission for Evangelical Outreach.
- □ A Boundary Workshop for deacons was held on February 4 at Our Savior's Atonement. 12 deacons attended.
- Diaconate Coordinators in Suffolk County organized and facilitated 2 study workshops during the past year. More opportunities are being investigated throughout the Synod to offer those serving in diaconal ministries interesting and helpful continuing education. In addition, more Saturday offerings of the Boundary Workshop will be planned for to accommodate deacons who are not able to attend during the week.
