I. CALL TO ORDER Bishop Bouman called the meeting to order at 5:10 p.m.

II. DEVOTIONS

Bishop Bouman also introduced synod staff and expressed his gratitude for their gifts and dedication to the vision and mission of this synod.

Bishop Bouman shared that he was prepared to stand for re-election after the churchwide assembly, but then received a letter nominating him for the position of Executive Director of the Evangelical Outreach and Congregational Ministries unit of the ELCA. He went to Chicago with an "attitude of listening" and after a full day of meetings with several people, entered a time of discernment. Bishop Bouman contacted presiding Bishop Mark Hanson and accepted this call to the ECOM.

Bishop Bouman offered an official statement of resignation as bishop of the Metropolitan New York Synod effective 3 Feb 08. A letter of resignation addressed to Mr. Hans Vogel and the synod council is forthcoming. He will take some vacation time at the end of January and begin at the EOCM on 4 Feb 08.

Bishop Bouman believes that the ELCA wants to learn from what has been developing in Metro New York. The ELCA wanted a missionary bishop who can work with the Conference of Bishops, and the seminaries on a national level.

Bishop Bouman stated his concerns and fears as we transition. The ELCA is 97% white. The MNYS is close to 33% non-white. He reminded the council that as a synod – we've collectively built our Latino ministries, our Asian ministries, our campus and outdoor ministries. We have become a resource on immigration and other social justice issues. He warned that we cannot afford factional politics or to loose "the vision" of Isaiah 58. We need to welcome the stranger in our midst. Bishop's hope is that we will let the vision minister to us. His sense is the synod does not want to rush through an election, but do some "due diligence". We need stability in the office and we have a good staff that will push the vision and keep us on point.

The Bishop appointed the Rev. James Krauser, Secretary, to chair the meeting in the absence of Mr. Hans Vogel, Vice-President. No exception was taken.

- III. ADOPTION OF AGENDA The agenda was adopted as presented
- IV. MINUTES, September 18, 2007, consideration of It was noted that Bishop Younan's name was spelled incorrectly. The minutes were approved as corrected.

V. SPECIAL GUESTS

Bishop Bouman welcomed the Rev. Kathie Bender Schwich and Ms. Tammy Jackson from the Office of the Presiding Bishop and indicated that both have worked with other synods through the process of transition between bishops many times – most recently in the Caribbean Synod.

Pastor Bender Schwich explained that the function of the Synodical and Constituent Relations Unit of the Office of the Presiding Bishop's is to support the mission and ministry of each synod in their own particular area, but most especially in times of transition. She gave assurance that she and her department are at our disposal, and will walk with the MNYS through the process of bidding farewell to Bishop Bouman and greeting a new bishop.

Pr. Bender Schwich distributed a Synod Transition Checklist (**EXHIBIT A**) which provides guidance through the steps of:

- Closure with an outgoing bishop and welcoming a new bishop
- Preparation for interim bishop
- Preparation for bishop's election
- Other Details (transfer of files and documents; transfer to signature authorization, etc.)

She went through the checklist line by line – fielding questions and offering explanation and clarification. Printed information from the Southwestern Minnesota Synod and the Northeastern Ohio Synod (**EXHIBIT B**) was provided to the council as a helpful model for MNYS.

Pr. Bender Schwich explained the process of a *Synod Ministry Audit*. This evaluation tool is conducted by the ELCA Synodical Relations Unit and enables a synod to determine its needs and develop a profile. This resource proves helpful in a synod's discernment process. This synod ministry audit can be conducted over a 2-3 day period with a report to the synod council six weeks prior to the synod assembly.

Ms. Tammy Jackson emphasized the value of communication – communication – communication – timelines and transparency throughout the process. Ms. Jackson stressed the importance of strong leadership during the time of transition to alleviate anxiety and fear.

Discussion determined that an interim bishop for the care of staff and for good order would best serve the synod.

On behalf of the Executive Committee, Mr. Buescher moved four (4) motions for consideration and adoption by the synod council.

VI. REPORT OF THE BISHOP

- a. Comments on issues of the wider church, synod, congregations, and the public arena
 - i. Bishop Bouman introduced Mr. Howard Capell. Mr. Capell provided a report to inform and update the synod council on several situations concerning congregations in the synod. Mr. Capell noted that there are many congregations in distress. There have been some property sales and several are under synod administration. Mr. Capell stated that several of the congregations have filed civil court action against the synod. Mr. Phil Harris (ELCA legal counsel) are collaborating on our responses. In addition to Bethlehem, Brooklyn, Mr. Capell updated the synod council on St. Paul's, Richmond Hill and St. John's in the Bronx.
 - ii. Bishop Bouman introduced Pr. Robert Wollenburg to inform and update the synod council on our partnership with the Evangelical Lutheran Church in Tanzania. Pr. Wollenburg spoke about our synods commitment to complete by May 2008 the 1M endowment that will support and maintain Christian education (incl. our teachers) in our companion synod. We are currently 225K short of our goal. Pr. Wollenburg has asked that between now and the May assembly, we as a synod act intentionally to meet our goal either in gifts or

pledges. A formula for raising the funds in the 18 conferences has been developed and was included in a letter to conference deans dated 01 Nov 07 (EXHIBIT D)

- iii. Staff reviews went very well. The Bishop expressed his appreciation of a gifted and dedicated staff. He also thanked Pr. Brenda Smith and Mr. Paul Jensen for their participation on the staff review team.
- iv. The Town Hall Meetings have been very successful. There has been great attendance and good participation. Pr. Wollenburg and Ms. Sarah Gioe have done a super job in organizing and coordinating them.
- B. Public Ministry:

November 27, 2007

- Bishop Bouman will be joining an interfaith delegation from the United States to 1. dialogue with Iranian religious, political and academic leaders. The delegation includes former Senator Chuck Hagel, UN ambassador John Danforth, and several religious (interfaith) and political leaders. The theme is "Statecraft in the Abrahamic Traditions." He will be giving a presentation on Luther's "Two Kingdoms" theology. These conversations are sponsored by PRIO, (the International Peace Research Institute, Oslo), and the Vatican through the Columbus School of Law at the Catholic University of America, Washington D.C. These interfaith conversations will be important in the years ahead in our global community.
- The Bishop will <u>not</u> be traveling to Jerusalem with Wagner students in January. 2. Pr. Gary Mills will assume that responsibility and make that trip instead.

REPORT OF THE TREASURER VII.

Mr. Buescher distributed the current Congregation Partnership Support report (EXHIBIT G) and the Property Assets report (EXHIBIT H). Please see the following for details:

Mr. Buescher directed the council's attention to the Congregation partnership report and the Mission Support Summary YTD (thru 10/31/07). If we continue on this course we will meet our 1.4M budget. The signs are encouraging, but we must continue to exercise careful supervision of spending. Comparison charts on property assets, funds covered by cash assets, and operating expenses as compared to overall funds were provided.

The Executive Committee has been working diligently on updating the Ten Year Plan. The intent of the plan was to restrict or limit the spending of funds obtained from property sales. At the "Ten Year Plan" meetings, the committee has been looking at "what ifs", which include limiting salary increases for staff. Mr. Buescher noted that not all the elements of the plan are in place, but the plan will remain conservative as the study of staff costs and functions continue. The Financial Management Committee wants to present a budget for 2009 at the upcoming synod assembly.

RESOLVED: that the Officers of the Metropolitan New York Synod of the Evangelical Lutheran Church In America, acting solely and on behalf of the Synod be and hereby are authorized, empowered and directed to negotiate and sign a lease agreement with Messiah Lutheran Church, 42-15 165th Street, Flushing NY for the use of the property located at 202-16 23rd Avenue Bayside, NY, with terms substantially in accord with the following conditions:

- **1.** The Synod will retain title to the property and will retain appropriate comprehensive insurance for the building.
- 2. The Synod will be responsible for major repairs (e.g. roof, boiler replacement, etc). (None are anticipated as of Nov 2007.)
- 3. Messiah will be responsible for all utilities and routine maintenance of the building and grounds, including minor repairs to appliances.
- 4. Messiah will be responsible for any insurance for the contents.
- 5. Messiah may only use the premise for housing for called pastoral staff unless the Synod agrees in writing to a change in this condition.
- 6. The lease is immediately terminated if the pastor accepts a call to another congregation.

Mr. Jonathan Westerlund reported on his trip to Tanzania and the transforming experience of meeting the young girl was an AIDS orphan. Jonathan also reported on the most recent events including "Fright Fest" at Great Adventure in New Jersey. Eight congregations participated. The Jr. High Retreat (Feb 22-24 2008) and the Sr. High Retreat (Feb 29 – Mar 2) are both planned for Koinonia. Positions are still available on the LYO board.

Ms. Marion Steadman reported on the upcoming Triennial Gathering of the Women of the ELCA in July 2008 in Salt Lake City, Utah. She also noted the focus of WELCA on fair trade products and the campaign to intentionally purchase those products in our supermarkets. In March 2008, a WELCA Super Saturday is planned at the Wartburg. The focus will be on domestic violence and child abuse awareness. Ms. Steadman also stated that the organization is asking for the submittal of congregational events to be published in the Witness.
