# III. ADOPTION OF AGENDA

The agenda was adopted as presented.

IV. MINUTES, April 17, 2007 and Special Meeting May 19, 2007, consideration of The minutes were approved as written.

### V. REPORT OF THE BISHOP

- A. Comments on issues of the wider church, synod, congregations, and the public arena
  - 1. Bishop Bouman spoke to the recent statement by the Pope that Protestant churches were not true churches. He thanked Pastor McElderry for his role in arranging a radio interview around this. Bishop has been getting calls about the Pope's statement and will be making a response.
  - 2. Bishop talked about the indebtedness of Epiphany Hempstead, and the fact that they are not paying their pastor's health benefits. He will make

- pastoral phone call to Pastor Oberkehr.
- 3. Bishop Bouman reported on the synod's progress in response to a resolution from the Western Suffolk conference asking for more intentional pastoral care in the synod.
  - a. We just had our first ever retreat for first-call pastors and plan to have one each year.
  - b. The staff has been wrestling with the whole area of pastoral care in general, for support in times of conflict, illness, etc. This has ramifications for how we structure the staff and our budget. He expressed a need for a succinct statement on pastoral care how we do it and how we do it relationally.
  - c. He is starting an online meeting with the senior staff regarding pastoral care and has begun to set up monthly meetings to deal with this in addition to their weekly Monday morning meetings.
- 4. He commented on the excellence of Pastor Chris Mietlowski's case study on his years in ministry and is looking at the possibility of having it published.
- 5. He commented on his recent trip to Romania, our new companion synod. He plans to invite the Bishop Dezso Adjorani of the Evangelical Lutheran Church of Romania Church and Bishop Buberwa from the North Western Diocese of Tanzania to our 2008 Synod Assembly.
  - a. Immigration: Bishop Mark Sisk of the Episcopal Diocese of New York and Bishop Bouman had a meeting of judicatory heads around issues of immigration. It was well attended and included Cardinal Egan. Fr. Kevin Sullivan of the Archdiocese of New York will work in cooperation with our immigration task force in trying to get everyone on the same page for an ecumenical effort. They will focus particularly on general theological principles put in the context of those immigrants who are already here.
- 6. This fall Bishop Bouman will be at all the Town Hall Meetings.
- 7. Bishop Bouman reviewed the situation at St. Peter's on Bedford Street in Brooklyn, where MNYS has been working with Lutheran Social Services (LSS) on a building plan. On May 29 MNYS representatives met with LSS, who presented a plan for St. Peter's. Bishop Bouman declined to sign it because it provided no permanent worship space and St. Peter's would not be able to display a sign with its name. LSS submitted the plan to HUD without Bishop's signature; Bishop sent them a letter asking that they cease and desist. He does want to continue to work with LSS on this but said that we need more time.
- 8. At the Churchwide Assembly in August there will be memorials asking the ELCA to change its policy on gay and lesbian pastors. Several pastors in our synod will join about 40 around the country saying they are gay and not called to life long celibacy.

**RESOLVED**, that each and every officer of the Synod be and they hereby are authorized, empowered and directed to utilize the net proceeds from the sale of the Property, after payment of the customary and/or required closing costs, transfer taxes, attorney and other professional fees relating to the sales, in furtherance of the purposes for which the Synod was formed, in accordance with its Certificate of Incorporation and Constitution and By-Laws; and it is further

**RESOLVED,** that the dissolution of the Synod is not contemplated following the transfer of the Property.
