F. Salem Danish, Brooklyn: resolution for sale

WHEREAS, the Synod Council of the Synod at its meeting held on September 11, 2010 duly adopted resolutions with regard to Salems Danish Evangelical Lutheran Church also known as Salems Danske Evangelisk Menighed (Salems) located at 345 Ovington Avenue, Brooklyn, New York whereby, the Synod imposed synodical administration to take charge and control over the assets of Salems to hold, manage and convey on behalf of the Synod pursuant to Synod Constitution, Section 13.24, and.

WHEREAS, title to the property of Salems remains in the name of Salems, having never been transferred to said Synod, and

WHEREAS, the property is surplus property and is not needed by the Synod in conducting the mission and ministry services it provides to the member congregations of the EVANGELICAL LUTHERAN CHURCH IN AMERICA in the New York Metropolitan area; and

WHEREAS, the Synod having determined to sell the property, an appraisal of the Property was performed reflecting a fair market value for the Property of One Million Five Hundred Thousand (\$1,500,000.00) Dollars in its present "as is" condition; and

WHEREAS, having listed the Property for sale, and having received a number of offers, and the best and most compelling offer having been received from XI HUI WU AND XIAO RONG YANG in the amount of One Million Five Hundred Thousand (\$1,500,000.00) Dollars, all cash, "as is", with no contingencies, based on the terms and conditions contained in the Agreement of Purchase and Sale annexed hereto; and

WHEREAS, the Council having undertaken to consider whether the sale of the Property to XI HUI WU AND XIAO RONG YANG based on the terms and conditions as above recited, and

WHEREAS, upon due consideration, the Council having determined that it is in the best interests of the Synod to sell the Property to XI HUI WU AND XIAO RONG YANG based on the terms and conditions as above recited, and to pay to REMAX TEAM a brokerage commission of 2% of the sales price and FILLMORE REAL ESTATE a brokerage commission of 2% of the sales price, payable if, as, and when title closes and out of the proceeds of sale;
