# 3. Strategic Plan Implementation

# A. CLAIMED Strategy

a. Presentation: Dcn. John Malone, Chair, presented the proposed "tag-line" for our synod – "Walking Together." This conveys a sense of community.

## B. GATHERED Strategy

a. Conference Pilot Projects

#### 1. Bronx Conference

Pr. Marc Herbst reported on a follow-up meeting at the Wartburg in January with pastors, lay leaders, members of the Synod Pastoral Care Team, and members of Synod staff. The purpose of the meeting was to review the Daxko facility study and explore possible partnership with Wartburg in developing some of the Bronx properties.

## 2. SW Queens Project

Pr. Marc Herbst reported that four congregations in SW Queens will hold congregational meetings on March 1 and vote to close their individual congregations in order to join in the formation of one regional congregation. Bishop Rimbo sent a letter requesting that each congregation call a special meeting . A Q & A, in English and Spanish, was provided to the congregations.

## C. SENT Strategy

a. Service for Justice & Reconciliation (17 January 2015)

Ms. Barbara Johnson, co-chair of Sent Committee reported on the service. Over 250 people gathered together on January 17 at Saint Peter's, Manhattan to call for peace amidst racial tensions around the country – and especially in New York City. The spirit was hopeful, the music was uplifting, and the message of confronting racism was powerful. Mutual Conversation and Consolation followed the service. There was good media coverage of the event.

She also reported that the Sent Committee is looking into hiring a community organizer who will work with congregations in the synod.

Bishop Rimbo reported that he held individual appointments with 39 pastors in Manhattan, Bronx and Staten Island. Pastors enjoyed a relaxed Clergy Appreciation Dinner on Friday night (Jan 30), and congregational planning teams attended a free workshop on Saturday (Jan 31) led by Tom Massey and Pr. Marc Herbst.

More than 25 congregations began conversations about strategic planning for their parishes, and over 80 people engaged in mutual conversation and consolation.
