# Resolution:

WHEREAS, Church of Christ's Evangelical Lutheran Church of Ramapo Rockland County New York (a/k/a Christ Evangelical Lutheran Church) ("Christ Suffern") was an interdependent member congregation of the Evangelical Lutheran Church in America (the "Church") and the Synod; and

WHEREAS, Christ Suffern owns the following real property: (a) 3 Church Road, Suffern, New York 10901 (55.19-2-27 and 55.19-2-27.1), (b) 1 Church Road, Suffern, New York 10901 (55.19-2-27.1),

27.2), (c) 68 Airmont South Road, Suffern, New York 10901 (55.19-2-28), (d) 68A Airmont South Road, Suffern, New York 10901 (55.19-2-30), and (e) 51A Airmont South Road, Suffern, New York 10901 (55.19-1-60) (collectively, the "Property"); and

WHEREAS, ownership of the property of Christ Suffern, as an interdependent member congregation of the Church and Synod, is governed by the Constitutions of the Church, the Synod and the Congregation, each of which state that title to the undisposed property of a congregation that ceases to exist shall pass to the Synod; and

WHEREAS, section 13.24 of the Constitution of the Synod provides that:

If any congregation of this synod has disbanded, or if the members of a congregation agree that it is no longer possible for it to function as such, or if it is the opinion of the Synod Council that the membership of a congregation has become so scattered or so diminished in numbers as to make it impractical for such a congregation to fulfill the purposes for which it was organized or that it is necessary for this synod to protect the congregation's property from waste and deterioration, the Synod Council, itself or through trustees appointed by it, may take charge and control of the property of the congregation to hold, manage and convey the same on behalf of this synod. The congregation shall have the right to appeal the decision to the Synod Assembly.

and

WHEREAS, in addition, New York Religious Corporations Law section 17-c(2) provides that:

Congregations of the Evangelical Lutheran Church in America. (a)The relationship between a congregation of the Evangelical Lutheran Church in America and the church may be terminated in one of the following ways:

(i) The congregation takes action to dissolve;

(ii) The congregation ceases to exist;

(iii) The membership of the congregation becomes so scattered or diminished in numbers as to make it impracticable for such congregation to fulfill the purposes for which it was organized. In such case, the synod in order to protect the property from waste and deterioration, through the synod council or trustees appointed by it, may take charge and control of the property of the congregation to hold, manage, and convey the same on behalf of the synod. The congregation shall have the right to appeal the decision to the synod assembly; (c) Subject to the provisions of the governing documents of congregations recognized at the establishment of the Evangelical Lutheran Church in America, the following shall govern the ownership of property by congregations of the Evangelical Lutheran Church in America: \* \* \*

\* \* \*

(ii) Title to the undisposed property of a congregation that ceases to exist by virtue of subparagraph (i), (ii) or (iii) of paragraph (a) of this subdivision, shall pass to the synod of this church to which the congregation is related;

(iii) Title to the property of a congregation that is no longer recognized by this church as a result of discipline shall continue to reside in the congregation;

and

WHEREAS, the congregation of Christ Suffern acknowledged that it was no longer possible for it to function as such and voted to disband, pursuant to section 13.24 of the Constitution of the Synod. In addition, the Synod Council is of the opinion that the membership of the congregation of Christ Suffern has become so scattered and so diminished in numbers as to make it impractical for that congregation to fulfill the purposes for which it was organized and that it is necessary for the Synod to protect the congregation's property from waste and deterioration, and therefore it is in best interests of the Synod to take charge and control of the property of Christ Suffern and to hold, manage and convey the same on behalf of the Synod; and

WHEREAS, title to the real and personal property of Christ Suffern shall pass to the Synod and it is in the best interests of the Synod to insulate the Synod from liability and for other reasons, to convey part of the real property formerly of Christ Suffern to two different limited liability companies in which the Synod will be and shall remain the sole member and manager thereof; and

WHEREAS, in furtherance of that purpose, the Synod intends to form 51A Airmont Rd S Cemetery LLC and 3 Church Road LLC with the intention of conveying to: (a) 51A Airmont Rd S Cemetery LLC title to the real property formerly of Christ Suffern known as and by street address 51A Airmont South Road, Suffern, New York 10901 (55.19-1-60) and (b) 3 Church Road LLC title to the real property formerly of Christ Suffern known as and by street address 68 Airmont South Road, Suffern, New York 10901 (55.19-2-28), and 68A Airmont South Road, Suffern, New York 10901 (55.19-2-30); and

WHEREAS, the sole purpose of 51A Airmont Rd S Cemetery LLC and 3 Church Road LLC is

and shall continue to be to hold, manage, and convey title to the real property formerly of Christ Suffern for, on behalf of, and at the direction and convenience of the Synod; and

#### NOW THEREFORE, be it

RESOLVED, that for the reasons set forth above, all of which are included and incorporated herein and made a part hereof as if fully set forth, the Synod, pursuant to Section 13.24 of its constitution and New York Religious Corporations Law section 17-c(2), does hereby take charge and control of the real and personal property (including the Property) of Christ Suffern to hold, manage, and convey it on behalf of the Synod; and it is further

RESOLVED, that based upon the facts recited and for the reasons set forth above, all of which are included and incorporated herein and made a part hereof as if fully set forth here, the Synod Council hereby approves of the formation by the Synod of 51A Airmont Rd S Cemetery LLC and 3 Church Road LLC, limited liability companies organized under the laws of the State of New York, in which the Synod is and shall continue to be the sole member and manager, with the intention of conveying to (a) 51A Airmont Rd S Cemetery LLC title to a portion of the real property formerly of Christ Suffern known as and by street address 51A Airmont South Road, Suffern, New York 10901 (55.19-1-60) and (b) 3 Church Road LLC title to a portion of the real property formerly of Christ Suffern known as and by street addresses 68 Airmont South Road, Suffern, New York 10901 (55.19-2-28), and 68A Airmont South Road, Suffern, New York 10901 (55.19-2-30); and it is further

RESOLVED, the sole purpose of 51A Airmont Rd S Cemetery LLC and 3 Church Road LLC is and shall continue to be to hold, manage, and convey title to a portion of the real property formerly of Christ Suffern for, on behalf of, and at the direction and convenience of the Synod, its sole member and manager; and it is further

RESOLVED, that the dissolution of the Synod is not contemplated following the transfer of the real and personal property of Christ Suffern to the Synod, the formation and transfer a portion of the property to 51A Airmont Rd S Cemetery LLC and 3 Church Road LLC.
