Dear Friends in Christ,

Welcome to our 2021 (Digital) Assembly. This year's theme, **We Are Church TOGETHER**, has been and will continue to be lived out in ways most of us hadn't anticipated not long ago but that still embody the reality of our common identity as children of God. In our gathering we will celebrate and reaffirm our commitment to the Gospel and to each other, hear

about significant ministries, and gratefully acknowledge our partnership within our synod and as members of the Evangelical Lutheran Church in America and with our ecumenical companions.

The COVID-19 pandemic has forced us all to experiment with digital platforms and tools while expanding our creativity. BEING CHURCH together

For years, I had (choosing my words cautiously) some trouble with an administrator at my son's elementary school. My son requires specialized support, to which he is entitled by law, and I did not think the administrator was taking appropriate steps to coordinate that support. I grumbled quite a bit about this situation. One day, I was doing the grumbling to a friend whose

children attended the same school and also required extra support. My friend heard me out with both sympathy and relevant experience; she said she shared my opinion about the administrator's job performance, and that his sloppiness was detrimental to her children, too. We both complained, until my friend said—

"You know what's difficult, though? He and his family are members of my congregation. I see them at church every week."

Full stop. My friend's reference to seeing the administrator at church brought an instant change in both of our composures. We stopped complaining about his job performance. Instead, I asked my friend whether she knew the administrator's family well, whether his wife also worked locally, where his own children attended school, even whether he enjoyed churchrelated activities beyond Sunday services. The discussion shifted from a person limited in his job capacity, and the trouble that his work gave us, to a whole person and how we might relate. What is it about being church together? I think being church together forces us to see our neighbors as fellow children of our loving God, with the same foibles, shortcomings, and imperfections we ourselves must acknowledge.

Even as children, many of us heard Jesus' words in Luke 6: "But I say to you who hear, love your enemies, do good to those who hate you, bless those who curse you, pray for those who abuse you." That seems straightforward enough: When faced with hate, respond with love. But what about when not faced with hate? What about when faced with annovance, or inconvenience, or even boredom or tedium? We are all human; we see people every day who rub us the wrong way, and we judge them, like humans are apt to do. She talks too much. He argues all the time. They have plenty to give but never offer. In my experience, breaking bread together, passing the peace, even joining voices in a hymn of praise—these are all shared moments that make judgments harder to sustain. Worshipping together reminds us that we all reside equally in the Lord's eyes, and that we all fall far short. Can you spend a homily passing judgment on the sibling to your side? I sure can't.

And the effect is not limited to our fellow congregants, or fellow Lutherans, or fellow Christians. When we spend our time in worship with those for whom, elsewhere, we might feel disdain, we develop a skill set. I used mine last week. An online group in which I participate, founded by one of my law school classmates, was having a discussion about whether the group should, generally, switch to using "they" to describe any individual whose preferred gender pronoun was unknown. I commented against the proposal. I said that the traditionally plural pronoun "they" would be too confusing, because we would not know whether we were speaking of one individual or a group of individuals. I said we should come up with a better, un-gendered pronoun, and then debate whether to make such a change. Within just a few minutes, a commentator, whom I did not know, fired off several public responses to me. Each one was unkind; he mocked my comment, deliberately mangled my name, and then called me "lazy" and "judgmental."

I bristled, of course. Quickly, I realized we were not on the same page. I was responding to a suggestion that we begin using "they" as a default; he had understood me to be denying that I would call a person by a pronoun other than "he" or "she," if requested to do so. I thought about responding to clarify, but reconsidered. What would be the use of that when someone was already flinging insults, and when I, in turn, was perturbed? As Proverbs 15:1 says, "A soft answer turns away wrath, but a harsh word stirs up anger."

I decided to find a better use for my iPhone (the device on which this conversation was taking place). I navigated directly to a local charity group, found that a family near me needed a kitchen wastebasket, and messaged that family to ask if I could bring them a new wastebasket the following morning. The family's response was so prompt, and so joyful, that my own peacefulness returned, and then, almost without being conscious of the change, I was seeing the person who had called me "lazy" and "judgmental" in a more empathetic light. What kind of discrimination, or even hatred, had this person experienced to cause him to respond with aggression and unwarranted assumptions? What pain lay behind his actions?

As I look back on that incident, I realize that what intervened that is, what prevented me from striking at anger with more anger—was a flash of "church together." I had a moment of remembering, as I do also when I worship with others, that everything looks different in the light of God's unwavering acceptance.

Coming together to worship, and serving others in Jesus' name, are ways in which we understand our role in creation. If we are called to welcome any person into the pews, to worship, we should also remember that the pews extend, figuratively, beyond the building's door and out into the world.

We often sing "They Will Know We Are Christians by Our Love." I believe Peter Scholtes, the author of that hymn, found inspiration in John 13:34-35: "A new commandment I give unto you, that you love one another; as I have loved you, that you also love one another. By this shall all [people] know that you are my disciples, if you have love for one another." Jesus' message is of the siblinghood of all humanity. **Being church together is how we practice His commands. We create a love that radiates outward.**

NOMINATIONS AND ELECTIONS FORM

At our 2021 Synod Assembly we will be electing persons to our **Synod Council, Consultation Committee, Discipline Committee, and Churchwide Assembly Voting Members Roster.** Below, you will find both the listing of open seats and a description of the position. We strongly recommend those nominated are familiar with the position, click <u>here</u> for more information.

SYNOD COUNCIL COMMITTEE

The Synod Council serves as a board of directors that makes legislative decisions between Synod Assemblies. The Synod Council exercises trusteeship responsibilities, recommends goals and budgets to the assembly, carries out resolutions of the assembly, reviews the official rosters and rostered leaders' statuses, issues calls, as well as supervising the work of committees (S.10).

CONSULTATION COMMITTEE

The Consultation Committee consists of twelve persons, of whom six shall be lay and six shall be Ministers of Word and Sacrament/Service, who shall be elected for a term of six years. Members of the Consultation Committee are called to consider matters of adjudication in a congregation. The functions of the Consultation Committee are set forth in Chapter 17 of our synod constitution.

DISCIPLINE COMMITTEE

The Committee on Discipline shall consist of twelve persons of whom six shall be ministers of Word and Sacrament/Service, and six shall be lay who shall be elected for a term of six years. The Committee on Discipline shall be responsible for the process of discipline governing officers, ministers of Word and Sacrament, ministers of Word and Service, congregations, and members of congregations in accordance with Chapter 20 of the Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America.

2022 CHURCHWIDE ASSEMBLY VOTING MEMBERS

The Churchwide Assembly is the highest legislative authority of the churchwide organization.
